I, Sri Sadananda Pal, S/O Sri Chandra Sekhar Pal, presently posted at Mejia CCC as Station Manager would like to lodge a complaint against Sri Ranjit Das & Sri Biswajit Das, S/O Lt Akshay Das of Vill Shyamapur, Near Pump House, Mejia, PS Mejia for physical assault of on duty CFO of Mejia CCC.

As per the written statement (Original Copy enclosed) received on 22.06.2020 from Sri Siddheswar Garai, S/O Sri Santi Garai, on duty CFO of Mejia CCC that on 20.06.2020 at about 04:00 PM Sri Ranjit Das & Sri Biswajit Das, S/O Lt Akshay Das of Vill Shyamapur, Near Pump House, Mejia, PS Mejia came to Office and using foul language, physically assault to him and also threatened him and also phone called on emergency mobile van number of Mejia CCC “7479240960” and threatening to the worker of Mobile van and usage of foul languages (This information has been received verbally from Sri Sanjoy Mukherjee, on duty Supervisor of Mobile Van).

Such activities are clearly illegal in nature and are causing mental harassment to the workers who work to ensure uninterrupted power supply throughout their jurisdiction.

Due to holiday (20.06.2020 & 21.06.2020) the written statement of Sri Siddheswar Garai has been received on today i.e. 22.06.2020 and it is my earnest request to you to accept this complaint and treat it as F.I.R. so that necessary legal proceedings can be taken against them.
