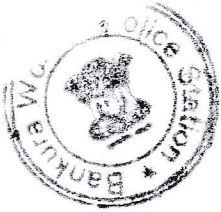

with due respect I beg to state you that I Khushboo Kumari Pathak age 30 years w/o - Dayanoy Pathak age (45), Pathak Para, Bankura, wanted to complain against my husband and mother-in-law. I got married on 1st May 2006 with Dayanoy Pathak (arrange marriage) and having two good child right now

From June 2006 to till now I am suffering a lot of pain by my husband and mother-in-law. They are doing to much torture (mentally and physically) on me and applying many thing like hands, legs, pipes to beat me. He is a drinker and most addicted in lathories. He spends all the money in these purposes only and not looking after my daughters and family. They are telling me to go out from their house and also always threats me to bring more money (Dowry) from my father.

Yesterday night he beats me a lot by hands, legs and pipes. Some black patches came on my body. He always give me threats to kill me and my daughters and also abuse very badly to my parents and my brother. Whenever I protest him to not to drink and about lathories. He use to beat me. My mother-in-law and my husband are not allowing me to get food from outside shop, whatever we suppose to get.

I as a teacher in S.D.I.S, Bankura earn money and look after my daughters and my family. I got injured very badly by him (husband) yesterday night.

Therefore I request you to do something against this
