Respected Sir,

In producing herewith following One(01) arrested person namely, Kajal Singha(48yrs.) S/O-Lt. Tinkari Singha of Vill+P.S-Simlapal,Dist-Bankura and brought under seizure one iron made 'Sword' length about 2½', under proper seizure list, I ASI Gouri Prasad Patra of Simlapal PS do hereby lodging this written complaint to the effect that, today on 27.07.20 received one telephonic information from P.S that one person is roaming with a open sword near Simlapal G.P. Office and terrorizing the local people. Duty officer also informed me that as per instruction of I/C Simlapal he is sending ASI(AB) Ashok Ghosh ,C/1210 Gopal Satpati ,CVF/119 Buddhadeb Chakraborty ,CVF/153 Balahari Karmakar, SPL CVF/198 Kousik Chhetri to help me. As we reached near Simlapal G.P. Office we saw one person is roaming with a long sword. As I approached him with intention to disarm him, he loudly told me "কছে এলেই মেয়ে ফেলব". I asked him to keep calm and as I reached near him he swing the sword towards my head with an intention to kill me. Somehow I dodged the deadly blow to my head but I received a sharp cut injury on my back by the sword. Seeing myself injured ASI(AB) Ashok Ghosh , CVF/153 Balahari Karmakar , CVF/119 Buddhadeb Chakraborty tried to help and as they came near him, he again swing the sword towards the head of CVF Balahari Karmakar to kill him. Who received serious cut injury on his both palm and fingers to prevent the deadly blow. Somehow myself ASI(AB) Ashok Ghosh ,C/1210 Gopal Satpati ,CVF/119 Buddhadeb Chakraborty ,CVF/153 Balahari Karmakar, SPL CVF/198 Kousik Chhetri were able to apprehend the person and disarm him. In this process ASI(AB) Ashok Ghosh ,and CVF/119 Buddhadeb Chakraborty also received injuries on their persons. On demand he disclosed his name and address as noted above. As further demand he failed to produce any paper or license in respect of possessing the iron made sword. As the Kajal Singha was tried to prevent me from discharging my Govt. duty after injured us with a sharp weapon with an intention to kill us. I arrested him, prepared arrest memo, seized the sword under proper seizure list duly signed by the witness and accused person. We injured persons treated ourselves at Simlapal B.P.H.C.

So, I brought him to P.S and put him into lockup after maintaining all formalities and submitted this complaint before you to start a specific case under proper section of law against arrested accused Kajal Singha S/O-Lt. Tinkari Singha of Vill+P.S Simlapal,Dist-Bankura and arrange for its investigation.
