Dear Sir,

This is to inform you that, as per written statement of on duty operator Sri Bamapada Khan and helper Sri Budharai Soren of Taldangra Substation, nearly about 01:07 hrs on 13.07.2020, the Taldangra local 11 kv feeder is tripped and after 3rd tripping the on duty operator declare the feeder as breakdown. The substation is fully covered the rural area and the HT maintenance team started their job towards early restoration of power. Accordingly power restored at 2:30 hrs, but in the mean time at nearly about 02:10 hrs Sri Subho Karmakar and others villagers of Bamundanga village were invaded (without maintaining social distancing as per the order of Govt. of West Bengal in this Covid 19 Pandemic Situation) at the control room of Taldangra 33/11 KV Sub-Station under Khatra Division WBSEDCL (which is a protected place as per under the Government of West Bengal Maintenance of public order Act, 1972 and rules frame there under), initially they started threatening along with abusive language and after that they assault physically to our on duty Operator and helper.

So you are requested to lodge a F.I.R. on that basis and take immediate strict action towards the culprits.
