On the morning of 19/7/20 at 1025 hrs
in the Taldangra PS, Bankura, a woman was found dead
at 10 AM on 20/7/20 in a well near the village of
Kanthalia, Taldangra PS. The woman was identified
as Kali Debi, aged 32 years, a housewife.
She was found hanging by her neck from a tree branch
near the well. She had been strangled with a cloth
around her neck. Her body was found near the well.
Her body was sent to the Bankura Medical
College for post-mortem examination. The post-mortem
report showed that she had been strangled.
The police are investigating the case.
