In producing herewith arrested two accused persons namely 1. Banshi Badan Khan (55) S/o Lt. Krishnapada Khan 2. Abhijit Khan (23) S/o Banshi Badan Khan Both of Vill- Saluni, P.O- Jhantipahari, PS-Chhatna, Dist-Bankura along with seized articles (1) 26 pieces bottle of country spirit on which written "Dil Se" measuring 600 ml each, Rs.- 60/- each bottle (2) 11 pieces bottle of country spirit on which written "CAPTAIN" measuring 600 ml each, Rs.- 110/- each bottle (3) 01(One) piece white colour plastic jarican containing approx 10 litters ID-Liquor (Rs. 125/ per litter), from which 375 ml ID-Liquor taken out as sample, one bottle of "Dil Se" & one bottle of "CAPTAIN" country spirit taken out as sample. I beg to report that today (26.08.2020) at about 18.45 hrs during my evening mobile duty, I received telephonic information from reliable sources that one person namely Banshi Badan Khan S/o Lt. Krishnapada Khan of Vill- Saluni, P.O- Jhantipahari, PS-Chhatna, Dist-Bankura selling ID-Liquor at his hotel styled as "MA DAKSHINA KALI HINDU HOTEL" at Saluni bazar beside Jhatipahari-Saltora pitch road (SH8) under Chhatna PS. Accordingly I informed the matter to OC Chhatna PS and as per his direction I along with C/553 Sudarshan Majhi, C/242 Soroj Karmakar and NVF/0448 Sanu Gorai rushed to the said hotel at saluni bazar. On reaching in the said Hotel under Chhatna PS, Dist-Bankura at about 19.35 hours, we found that two persons were selling ID- Liquor and country spirit. Seeing the police party and getting the scent of police some persons are tried to flee away but after a hot chase, I managed to apprehend the above noted accused persons. On search found the above noted articles are stock in their hotel. On being asked the above noted accused persons could not produce any valid documents or receipt/Challan from any competent Govt. authority in support of selling of such stock liquors. I seized the above noted articles from the possession of the above noted accused persons under proper seizure list and duly signed by the police personnel as none was available to signed the seizure list and arrested them by maintaining strict regard in decency. One copy of seizure list supplied to the male accused persons after observing all legal formalities.

It is evidence that the above noted accused two persons are liable to be prosecuted U/S 46 (A) B.E Act.


So, I pray before you that a case may kindly be started against the above noted two accused persons under proper section of law and oblige.
