Sub: Complaint FIR

Sir,

With due most respectfully I Kartik Rongdar, Sub Inspector of Police of Ranibandh Police Station Dist- Bankura do here by lodge a written complaint against one Sambhu Ahiri (62 Yrs) S/O Lt Kalipado Ahiri of Vill- Ghagra, Holudkanali, PS- Ranibandh Dist -Bankura under arrests and beg to submit that on today (22.08.20) myself along with force namely C/1800 Ujjawal Prosad Bauri, C/939 Swarup Roy and NVF Uttam Mahata were engaged in PS area for mobile duty (This refers to Ranibandh GDE no- 780 Dated- 22.08.20 & CC No- 1184/20 Dated-22.08.20). At about 14.15 hrs received a secrete source information that one Sambhu Ahiri selling liquor illegally from his house at village Ghagra. Immediately I covey the information to I/C Ranibandh PS & after confirmation of that. I along with force held raid in his house and found some persons consuming liquor and said Sambhu Ahiri in selling liquor. On seeing the police party some persons succeed to flee away from his house and we success to apprehend one person. On asked he disclosed his identity as Sambhu Ahiri (62 Yrs) S/O Lt Kalipado Ahiri of Vill- Ghagra, Holudkanali, PS- Ranibandh Dist -Bankura as owner of the house. On being search I found that a plastic jar contents color less liquid about 10 lits, when I opens the mouth of said Jar, a strong smell of I/D liquor coming out from it.

I asked him to produced license or any valid documents in respect of storing and selling of said I/D liquors. But he failed to produce any valid license or documents before me. On being further asked he stated that he sells among the local people in exchange of money. Then I seized the said Jar contents said to be ID liquor, and some plastic glasses. from his possession after preparing proper seizure list and arrested him after observing all formalities of arrest and also prepared label on seized Jar with liquid and brought him to PS under arrest with seized jar and other article.

Under the above fact and circumstances I am praying for registering a case U/S 46 A(c) B.E Act against arrested accused person for regular investigation..
