Sub: Prayer for starting a cog. Case u/s: 399/ 402 IPC

Sir,

In producing herewith the following accd. persons namely 1. Sk. Jahir (30yrs), s/o: Sk. Abul of Sankattola 2. Badal Dome@ Badal Madrazi@ Naggot (22yrs), s/o: Shankar Dome of Municipality 3. Partha Mahanta@ Rana(28yrs), s/o: Lt. Bankim Mahanta of Tuntbari - all are of PS. Bishnupur, Dist. Bankura alongwith seized articles viz. 04 knives, an iron road measuring about 5'5" and one of its end is flattened [customarily used as house breaking tool], a spanner, four empty country spirit bottles, 06 plastic glasses some burnt bidi butts and one three cell old Eveready torch (details are in seizure list), I, SI. Ratan Majumder of Bishnupur P.S. would like to lodge a Suo- motto complaint against aforesaid 03 accd. persons and 5/6 other to the effect that today, as per schedule, today at 22:15hrs, got a piece of information from my source that few miscreants gathered at Chowkan More 4point crossing under Bishnupur PS with ulterior motives. I wrote down the matter in the GD book of the PS and this refers GDE No748 dated 18.09.2020. As instructed, I left the P.S. with other officers and force for executing the piece of information. This refers Bishnupur P.S. GDE No 749 dated 18.09.2020 and CC No. 3602 /2020, dated 18.09.2020.

In recent past, few attempts of theft have occurred in Bishnupur town. Sources were engaged and sharp vigil on the movements of known local criminals. Tracking on criminals was also kept with the help of SOG, Bankura.

Around 22:35hrs, reached at the close vicinity of the point of assembly. Kept my vehicle at a safe distance. After that, we moved to the place of assembly on foot. Cordoned off the area and disclosed our identity as Police. 05/06 persons fled away on perceiving our presence and we managed to apprehend only 03 accd. persons. On being interrogated, they disclosed their name and particulars, noted above and admitted that they alongwith 5/6 others had been planning to commit dacoity in the house at Senhati colony and Turkidanga areas. Searched the persons of those apprehended persons. A dagger, measuring about 3'6" with wooden handle was found from a nylon bag which was with Sk. Jahir. A long knife, measuring about 2'6" with wooden handle was found from the right waist of Partha Mahanta@ Rana. A knife, measuring about 03feet with wooden handle was found from the right waist of Badal Dome@ Badal Madrazi@ Maggot. I searched the area with the help of

lights we took with us. Found a long knife measuring about 03ft with wooden handle, wrapped in an old towel, an iron rod measuring about 5'5" and one of its end is flattened [customarily used as house breaking tool], a spanner, four empty country spirit bottles, 06 plastic glasses some burnt bidi butts and one three cell old Eveready torches. Those were seized under proper seizure list. As that place was isolated one and there was no people or residential area in close vicinity, I took the signatures of my accompanying forces. I could not seize the lower wearing apparels of Partha Mahanta@ Rana and Badal Dome@ Badal Madrazi@ Maggot as there were no other substitute. Entire search, seizure and arrest were done in between 22:45hrs and 23:45hrs.

After that I arrested all three accd. persons as per law and maintaining legal formalities and brought them to P.S. They were interrogated at PS. They stated that Deepak Bauri, Vijay Madrazi, SK Ramjan@ Muuna and 3/4 others fled away under the veil of darkness.

Under the above, I pray to you to start a cog. Case against accd. persons namely 1. Sk. Jahir (30yrs), s/o: Sk. Abul of Sankattola 2. Badal Dome@ Badal Madrazi@ Maggot (22yrs), s/o: Shankar Dome of Municipality 3. Partha Mahanta@ Rana(28yrs), s/o: Lt. Bankim Mahanta of Tuntbari - all are of PS. Bishnupur, Dist. Bankura 4. Deepak Bauri 5. Vijay Madrazi 6. SK Ramjan@ Muuna and 3/4 others.
