Sir,

In producing herewith the arrested accused person namely Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura along with seized article (1) Two plastic Jariken ( marked as SL no- 1& 2) containing approx 10 Lltrs each and total approx 20 Ltrs of ID liquor, (2) One pipe fitted funnel, (3) Two bottle of ID Liquor of approx 375 ml collected as sample from the each Jariken Si No 1 & 2 and duly sealed and labeled by me, I SI Swapan Mandal of Bishnupur PS do here by lodge complaint against one Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura to the effect that on 26.09.2020 at about 19.05 hrs received secret information over telephone from duty officer of PS that illegal manufacturing and selling of ID liquor is going on at the house of Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura. (This ref. to Bishnupur P.S. G.D.E. no- 1089, Dt.- 26.09.2020) Accordingly as per order of I/C, Bishnupur P.S I accompanied by force namely C/1383 Pradip Kr Mahato, C/157 Nirmal Ch Ghosh left for Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura to work out the information. . (This ref. to Bishnupur P.S. G.D.E. no- 1090, Dt.- 26.09.2020)

On 26.09.2020 at about 19.35 hrs I accompanied by force reached near the house of Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura. While proceeding to his house as identified by the local people, Seeing Police some persons who were sitting in the court yard of his house and taking liquor, started to flee away. We chased behind them. But all of them except manufacturer Sushil Lohar @ Bura managed to escape. I called some disinterested persons. In presence of some villagers and police personnel in between 19.40 hrs to 19.50 hrs searched the house from where those persons fled away and found (1) Two plastic Jarlken ( marked as St. no- 1& 2) containing approx 10 Litrs each and total approx 20 Ltrs of ID liquor, (2) One pipe fitted funnel, (3) Two bottle of ID Liquor of approx 375 ml collected as sample from the each Jariken SI No 1 & 2. On local enquiry I came to learn that the owner of that house Sushil Lohar @ Bura who was apprehended by us. He has been manufacturing and selling liquor illegally from his house and he is running this illegal business since long. I arrange to collect one bortle of ID liquor as sample from each Jariken containing liquor and sealed, labeled, and seized the same in presence of police witnesses namely C/1383 Pradip Kr Mahato, C/157 Nirmal Ch Ghosh both of Bishnupur PS under proper seizure list duly signed by them. On several request no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 19.50 hrs to 20.00 hrs duly Signed by the accused person.

On the spot on being search and ask neither he nor any one in favour of him came forward and produce any valid license against his illegal manufacture and sale of ID liquor. I interrogated him and during interrogation he confessed his guilt. Accordingly I arrested the accused person namely Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura. The approximate value of the article seized and destroyed is Rs 2250/- only.

Under the above circumstance, I request you to start a specific case against the said Sushil Lohar @ Bura (39 yrs), S/O- Lt Kalipada Lohar of Down cabingora, Ward no- 19, PS- Bishnupur, Dist- Bankura and arrange for its investigation.
