Sir,

With due respect I, SI Tapan Kr. Dalal of Onda PS, Dist- Bankura, do here by submit the complaint with the fact that today i.e. on 19/09/2020 at 14:15 Hrs. myself along with S.I. Malay Mahapatra and force namely C/1496 Madhu Das, C/1388 Sibaram Mahata and NVF-0753- Bikash Barik left Onda P.S. for Seoraghati Village under Medinipur G.P. to investigate Onda PS Case No- 142/2020 dt. 19.09.2020 U/S- 448/323/325/307/354/506/34 IPC. This refers to Onda P.S. GDE No. 810 dt. 19/09/2020 & vide Onda PS special C.C No- 192/2020 dt. 19.09.2020. I reached at Seoraghati Village at about 14:55 Hrs. and visited the P.O. and examined available witnesses and recorded their statement U/S 161 CrPC. During investigation, so far evidence collected I have found that the FIR named accused person namely Santosh Mal S/O Lt. Haripada Mal of Seoraghati, PO- Medinipur, PS- Onda Dist- Bankura is involved in this case and for the sake of proper investigation his arrest is required. After that myself along with S.I. Malay Mahapatra and force reached at the resident of FIR named accused Santosh Mal S/O- Lt. Haripada Mal at Village Seoraghati and held raid. But he was not found there. Then after getting an information that he is available at a newly constructed house situated just behind his residence, myself along with force held raid and arrested him. I have issued him Memo of Arrest and explained him as well as his relatives regarding the ground of arrest. But neither the arrested accused nor the family members agreed to put their signature on the Memo of Arrest. However, after arrest, while we took him from the place of arrest to our Govt. Vehicle bearing Regn. No- WB/68D 0019 which was kept in a distance, the arrested accused started shouting and called many persons there to obstruct us to take him to the Police Vehicle. Suddenly a good number of people (Men & Women) reached in front of our Govt. Vehicle armed with deadly weapons like Lathi, Rod etc. and obstructed us to take the arrested accused person to Police station. Some women laid down in front of our Vehicle. So we could not move from the place immediately. As there was no Lady Police Personnel was present at the spot with us, we could not use force. We have repeatedly told them not to obstruct us to discharge our Govt. duty, but they did not bother, but started shouting against us. They did not wear face mask and did not follow the norms of social distancing issued by the Govt. of West Bengal as well as Central Government to control the spread of Corona Virus. During the time with the help of the family members and neighbours the arrested accused person fled away from our custody in spite of our sincere effort. They have also assaulted us by Lathi, Rod etc. and three Police Personnel namely (1) C/1496- Madhu Das, (2) C/1388- Shibram Mahato and (3) NVF- 0753- Bikash Barik became injured and they were taken to Onda BPHC for necessary treatment. The following persons took the arrested accused person from our custody:- 1) Santosh Mal S/O- Lt. Haripada Mal, 2) Dhananjay Mal S/O- Lt. Haripada Mal, 3) Antu Mal S/O- Lt. Haripada Mal, 4) Saraswati Mal W/O- Santosh Mal, 5) Mamoni Mal W/O- Dhananjay Mal all of Seoraghati, PO- Medinipur, PS- Onda Dist- Bankura and there were at least 50 persons (Whose identities are yet to be established) who helped the arrested accused person to flee from our custody. Then after some time we managed to move from the place after dispersing the mob. But the agitated mob committed an offence which is punishable U/S 147/148/149/341/323/325/332/333/353/224/225/186/188 IPC & 51 of Disaster Management Act 2005.

So a specific case may kindly be started against 1) Santosh Mal, S/O- Lt. Haripada Mal, 2) Dhananjay Mal S/O- Lt. Haripada Mal, 3) Antu Mal S/O- Lt. Haripada Mal, 4) Saraswati Mal W/O- Santosh Mal, 5) Mamoni Mal W/O- Dhananjay Mal all of Seoraghati, PO- Medinipur, PS- Onda Dist- Bankura and approx 50 unknown others.
