Sir,


In producing herewith one Budhadeb Mondal (40 yrs), S/O- Tarani Mondal of Vill- Patjore, ,PS-Sonamukhi, Dist- Bankura along with the seized article 01 Jariken of id liquor contain 20 liters approx, taken 650 ml for sample file duly sealed & leveled by me in presence of witness & signed by accused. I ASI Sanjojoy Kr. Chakraborty of Sonamukhi PS do here by lodge complaint against one Budhadeb Mondal (40 yrs), S/O- Tarani Mondal of Vill- Patjore, ,PS-Sonamukhi, Dist- Bankura to the effect that on 26.09.2020 at about 12:45 hrs received secret information over telephone from duty officer of Sonamukhi PS that one person namely Buddhadeb Mondal selling id liquor from from his house to buyer, after getting search information myself along with C/427 Rabindranath Chakraborty, C/ 881 Prabir Pakhira & NVF- Balahari Majhi with govt. vehicle left for Patjore. (This refers Sonamukhi P.S G.D.E NO-1172, Dt-26.09.2020 & C.C NO- 2152/2020, Dt- 26.09.2020).

On 26.09.2020 I along with force were engaged for day mobile duty at about 12:45 hrs received telephonic information from PS that one person namely Budhadeb Mondal (40 yrs), S/O- Tarani Mondal of Vill- Patjore, ,PS-Sonamukhi, Dist- Bankura. Brought ID liquor from Hamirhati Jungle to his house to selling the ID liquor. I seized 01 Jariken of id liquor contain 20 liters approx, taken 650 ml for sample file duly sealed & leveled by me in presence of witness & signed by accused . On local enquiry I came to learn that the Budhadeb Mondal (40 yrs), S/O- Tarani Mondal of Vill- Patjore, ,PS-Sonamukhi, Dist- Bankura he has been carrying id liquor in his house from Hamirhati jungle to his house for selling the same. Seeing the police jeep people were gather there. I request them to sign the seizure list but none were agree to put the signature the seizure list. Then I arrest Buddhadeb Mondal who is violating the rules of Excise Rule. So he is liable to prosecuted U/S-46 B.E Act. After maintaining all formalities of arrest memo & guidelines of Hon'ble Apex Court. The approximate value of the article seized is Rs 1050/- only.

Under the above circumstance, I request you to start a specific case against the said Budhadeb Mondal (40 yrs), S/O- Tarani Mondal of Vill- Patjore, ,PS-Sonamukhi, Dist- Bankura and arrange for its investigation.


