Sir,

I, Supriya Sen W/O Sri Suman Majee and D/O Sri Sribash Chandra Sen, at present residing at Chhatna within P.S. Chhatna, Dist - Bankura do hereby lodge the complaint to the effect that I was married with Suman Majee S/O Sri Swapan Majee of Village & P.O. Sanka within P.S. Ragnathpur within P.S. Purulia on 20/04/2018 according to Hindu rites and rituals. My husband is an officer of ECL and now posted as Deputy Surveyor. After the marriage I went to my matrimonial home. Before my marriage I was working in the Puabagan English Medium School as a teacher, But immediately after the marriage I was forced to put resignation in the school accordingly I resigned when I was living in my matrimonial home, I was compelled to do all the house hold works from the dawn to the night. My husband and in-laws were not satisfied with the ornaments and other articles, gifted by my father and they used to make pinching me regarding those articles. My mother-in-law is suffering from mental problem for which I had to bear lot of troubles for her. In spite of all such things I stayed at my matrimonial home. Unfortunately my husband and my father-in-law started demanding money from me on different pretext. As I expressed that my father was not in a capacity to meet their demand, I was subjected to mental torture by my husband and my father-in-law. My mother-in-law used to provoke my husband continuously. In the mean time I got a job at Adra in a School but I was not allowed to join. I tried my best to make my husband understand my problems but he remained indifferent. On 29/10/2019 I apprised everything to my parents and meeting was held between the two families but of no good. The last meeting was held on 02/09/2020. My father-in-law is a most shrewd and concerning person. My husband always abide by the directions of his father I have become a victim of torture in a planned way of my husband and the parents-in-law. I am unable to stay at my matrimonial home as apprehend that I may be killed.

In view of the above I request you to initiate a FIR against my husband and my parents-in-law so that they get punished by the Ld. Court.
