Sub: Prayer for lodging an FIR under proper section of law against (1) Debu Das (33 yrs) S/O – Late Sanatan Das, vill+P.O. – Panchal, P.S – Sonamukhi, Dist – Bankura. (2) TarunKanti Mondal S/O- Late Prabhakar Mondal of vill-Nayanandapur, P.O- Majdiha, P.S-Onda, Dist – Bankura.

In producing herewith, the arrested accused person namely Debu Das (33 yrs) S/O – Late Sanatan Das, vill+P.O. – Panchal, P.S – Sonamukhi, Dist – Bankura along with seizure list and the seized articles as described below. I beg to state that on 25.10.2020 at 20:05hrs the duty officer of the P.S. had source information that some unknown persons brought liquor by motor cycle and will pass through Majdiha. He has diarized the information under Onda PS GDE No. 1092 dtd 25.10.2020 and informed to me. After receiving such information, myself along with C/1321 Harihar Das, C/140 Joyguru Saha & HG/34 Sukumar Duley left P.S. for executing the information vide Onda P.S. GDE No. 1093 dtd 25.10.2020 by PS vehicle bearing Regd No- WB 26 C/7361 and carrying white paper, gala, carbon paper, investigation kit etc. After having reached Majdiha, we placed Naka in between Nayanandapur and Kunchisole. After 20 minutes later we detained one person along with motorcycle bearing Registration No WB 44/5579 (Chasis No. MBLHA11ERA9L0833 & Engine No. HA11EDA9L12453). After detaining him we asked him about his identity. Being asked, he disclosed his identity as Debu Das (33 yrs) S/O – Late Sanatan Das, vill+P.O. – Panchal, P.S – Sonamukhi, Dist – Bankura. After that we informed him that we have information that he was carrying illegal liquor. So that we wanted to search his belonging (bag) which was tied at the backside of his motorcycle and found Beer from his bag.

After recovery of those articles, we demanded valid papers from him in support of his possession over this article but he failed to produce any valid documents in respect of that. I interrogate him about the purpose of the carrying and possessing the liquor said to be Beer. He replied that he collected Kingfisher Strong Premium Beer from TarunKanti Mondal S/O- Late Prabhakar Mondal of vill-Nayanandapur, P.O- Majdiha, P.S- Onda, Dist – Bankura illegally and after selling these Beer both of them get 50% of the profit each. As such, I seized the above items as ALAMAT under proper seizure list in between 21:20 hrs to 21:35 hrs. The seized articles are listed below-

- i) 8 bottles of Kingfisher Strong Premium Beer 650 ml each, Total Rs. 1088/-
ii) One Motor Cycle bearing registration no WB 44/5979 (Chasis No. MBLHA11ERA9L0833 & Engine No. HA11EDA9L12453).

Since the allegation against him of possessing, the Kingfisher Beer illegally without any valid papers for the business purpose has prima-facie been made out and for the interest of proper investigation, I arrested the above accused at 21:40 hrs accordingly.

Under the above circumstances, I pray before you, kindly lodge an FIR against (1) Debu Das (33 yrs) S/O - Late Sanatan Das, vill+P.O. - Panchal, P.S - Sonamukhi, Dist - Bankura, (2) Tarun Kanti Mondal S/O- Late Prabhakar Mondal of vill-Nayanandapur, P.O- Majdiha, P.S- Onda, Dist - Bankura under proper section of law.
