Re: <u>Outraging a woman's modesty on 26th Oct by SUJOY MANDAL to culminate a Verbal Threat given by JAY MANDAL on 14th Aug to "Hit her Hard"</u>

Today SUJOY MANDAL S/O Banamali Mandal & SUDIP MANDAL S/O Mrityunjoy Mandal, tried to outrage my modesty in an attempt to forcibly pull me out from DURGA TEMPLE at around 8am at Hadalnarayanpur Borobari.

I went to HadalNarayanpur Borobari, my ancestral temple to offer Pushpanjali on Dashami morning from Kolkata at around 7.45 am.

My brother, Dr Debajyoti Mandal who was accompanying me, also got physically assaulted in his attempt to save me from their clutches.

When we rushed to our car(WB02AE1665) to save our life, we found that both the tyres of my car were punctured by a sharp pointed object. On taking the car to the repair shop, I found that one of the tyres is permanently damaged.(Photo attached)

At that juncture, my brother was frantically calling PATRASAYER OC & BISHNUPUR SDPO for rescuing us, but unfortunately his calls were unanswered. He messaged both of them informing about the assault.

Please note that in our previous GD via mail to SDPO Bishnupur dated 18.08.2020, we had intimated about verbal threatning of JAY MANDAL S/o Radhakanta Mandal over phone. (GD & Audio Recording of Jay Mandal Attached)

On coming to know of our arrival today morning in HadalNaraynpur, Jay Mandal & Tumpa Mandal S/o Prashanta Mandal who had come from Bishnupur ganged up with Asit Baran Mandal S/O Kalipada Mandal to instigate Sujoy Mandal for carrying out the verbal threat of Jay Mandal dated 14.08.2020 " of hitting us hard".

Me and my brother are currenty stable after taking preliminary treatment from **Dr Debajyoti Panja**, Attending MO Patrasayer BPHC. He also registered individual Injury Reports. (**Treatment sheet attached for reference**)

- 2. SUDIP MANDAL S/O MRITYUNJOY MANDAL

For outraging a woman's modesty and physically assaulting my brother causing "GRIEVOUS HURT " to his face and neck.

Inspite of repeated reminders, no action has been taken against Jay Mandal and his gang, whereby as an aftermath we got assaulted today, and in all probability **this will be repeated** in future whenever we are coming to our own ancestral place.
