THAT SMT RUPA MANDAL D/O BIBEKANANDA MANDAL RESIDENT AT KURBANTOLA HRIDDHI TOWER 2ND FLOOR, NEAR THANA GORA, POST+PS: BISHNUPUR, DISTRICT: BANKURA IS THE COMPLAINANT IN THIS CASE IS THE LEGALLY WEDDED WIFE OF DR ASIM KUMAR NANDI S/O CHANDI CHARAN NANDI RESIDENT AT VILLAGE+POST: PAHARPUR, PS: INDAS, DISTRICT: BANKURA PRESENTLY RESIDENT AT VILLAGE: HETIA PRIMARY HEALTH CENTER UNDER JOYPLUR BPHC HOSPITAL, PS: JOYPLUR, DISTRICT: BANKURA, THEIR MARRIAGE WAS SOLEMNIZED ON 13/08/2011. MARRIAGE WAS NEGOTIATED ONE. DURING MARRIAGE FATHER OF THE COMPLAINANT HAD GIVEN ONE DEVAN KHAT, ONE ALMIRAH, ONE BIG CONTAINER OF BRASS, HANDI, BUCKET, TWO PITCHERS, THREE PLATES, PLATES OF KOTKI, JAMBATI, DISHES OF FOUR PIECES, THREE GLASSES AND BATIS, SAJIS, GHOTI ALL ARE MADE OF BRASS AS PER DEMAND LAID BY HUSBAND AND HIS FAMILY MEMBERS. COMPLAINANT HAS GIVEN BIRTH ONE FEMALE CHILD SO HUSBAND OF COMPLAINANT OFTEN USED TO INTIMIDATE "TO THROUGH FROM TOP OF THE FLOOR TO KILL THE GIRL CHILD ELSE ASK YOUR FATHER TO SEND MONEY". HUSBAND OF COMPLAINANT DID NOT ALLOW FATHER, MOTHER AND ELDER BROTHER OF COMPLAINANT TO MEET HER. IN LAWS FAMILY MEMBERS HAVE MISAPPROPRIATED STRIDHAN PROPERTIES OF THE COMPLAINANT LIKE ORNAMENTS MADE OF GOLD LIKE A PAIR OF BANGLES, NECKLES, THREE PAIR OF EAR RINGS, NOSE PIN MY DRESSES, WEARING APARELS, AND OTHER VALUABLE GIFTS GIVEN BY FATHER OF THE COMPLAINANT LIKE DIVAN KHAT, ONE ALMIRAH, ONE BIG CONTAINER OF BRASS, HANDI, BUCKET, TWO PITCHERS, THREE PLATES, PLATES OF KOTKI, JAMBATI, DISHES OF FOUR PIECES, THREE GLASSES AND BATIS, SAJIS, GHOTI ALL ARE MADE OF BRASS AT THE TIME OF MARRIAGE AND SO ON.
