On the way one motorcycle dashed that ambulance at around 3.30PM near Durbaganj, Natungram Pinishol under Ps Onda. After the accident that motorcycle driver and his companions forcibly detained that ambulance around 03 hours with gather more persons. Due to that ambulance and that patient could not reach Bankura Sammilani Hospital in due time causing the death of said patient. I also injured by Stepney rode done by them. Now I'm admitted. After a few hours the police personnel of Onda Ps reached there and brought that ambulance at Onda Ps. That ambulance is at present lying at Onda Ps compound. This is for your kind information that the ambulance is used by Sanaka Hospital for carrying serious patients for better treatment. Due to detention of that ambulance the normal work of Sanaka Hospital is hampering and patient party are lacking for ambulance service. In this circumstance I am requesting you to take necessary legal action against the bikes and others and his accompanying persons for their offence. So I am admitting in Sanaka Hospital in this time. So I did not submit the hard copy. I submit by email of my company.

I requested that kindly my complain launch against Motorbike Driver and others (Ram Mohan Pal Age-38) and his Brother (Gopinath Pal).

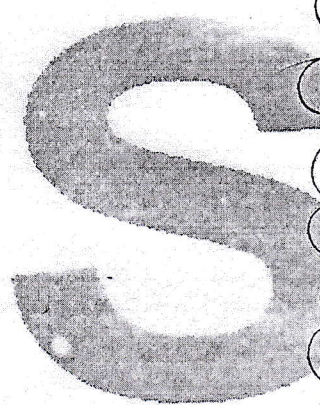
