Sub:- Prayer for lodging specific case U/S-379/411/34 IPC against 1) Binod Singh @ Anil [M/34 yrs] S/O-Lt. Delka Singh of Vill- Petapura, P.S-Narayangarh, Dist-Paschim Medinipur, 2) Sunil Murmu S/O- Not known of Armunda area , PS- Belda, Dist- Paschim Medinipur , 3) Joydeb Misra S/o- Not Noted of Belda area under Paschim Medinipur district.

Sir,

In producing herewith one arrested accused person namely Binod Singh @ Anil [M/34 yrs] S/O-Lt. Delka Singh of Vill-Petapura, P.S-Narayangarh, Dist-Paschim Medinipur along with one seized truck loaded with stone chips having Chassis No-MAT466420E1B02948, Engine No-41B63363796 on the body of which the vehicle number "WB 33 C 2537" was rubbed with another articles at the both sides (right and left) and in the front one number plate "WB 33B 7440" has been fixed. I have seized another number plate (written on it :- WB 33 C 2537) which was kept separately inside the cabin of the said truck, I beg to state that on 22.11.2020 myself SI Malay Mahapatra along with force were performing mobile patrolling duty in PS area as per detailment with following forces namely C/212 Laxmikanta Rajak NVF 0449 Amit Mahato, vide CC No-2991/2020 and Onda P.S GDE No- 894 dt 22.11.2020. During my mobile patrolling duty at about 20.35 hours I was directed to work out an Information (which was noted in Onda PS GDE No. 897 dated 22.11.2020) that one stolen truck is coming from Bankura side to Bishnupur side along Bankura- Bishnupur pitch road (NH 60) and its' number plate have been tampered by the miscreants. You directed me to work out the information seriously. Accordingly, myself along with force placed naka near BDO office Morh on NH 60 and started checking the on-going vehicles. During my naka, after sometime, I found that one truck stopped in a distance from us and one person has been found fleeing away from the driver's cabin. Myself along with force reached near the truck immediately and found another one person in the driver's cabin who was also trying to escape from the truck. But as we reached immediately, he could not escape. I found that one number plate "WB 33B 7440" is fixed in the front of the truck. But on the right side and left side of the truck the number was written as "WB 33 C 2537". It is also found that an attempt was made to make it illegible by rubbing on the number by some means.

I interrogated the person who was inside the driver's cabin who disclosed his name as Binod Singh @ Anil [M/34 yrs] S/O-Lt. Delka Singh of Vill-Petapura, P.S-Narayangarh, Dist-Paschim Medinipur. He identified himself as the helper of the said truck. He also told that the person who fled away from the cabin was the driver of the said truck and he knows his identity as Sunil Murmu S/O- Not known of Vill- Armunda, PS- Belda, Dist- Paschim Medinipur. I asked him to produce document in support of the ownership of the said truck , but he failed to produce and also disclosed after a prolonged interrogation that this truck has been stolen few months ago and one Joydeb Misra S/O- Not known of Belda area , Paschim Medinipur district along with the above noted driver of the truck who fled away and some others are involved in committing theft of the said truck.

The helper also disclosed that the number plate which is fixed in front of the truck having number "WB 33 B 7440 "is not the original number of the said vehicle. it has been fixed after

stealing the truck. Its original number plate" WB 33 C 2537" has been separated from the truck and it is kept inside the driver's cabin. The said helper brought the separated original number plate from the driver's cabin and I seized it under proper seizure list.

Thus, from the statement of the helper and from the primary enquiry, there is every reason to believe that this truck has been stolen by miscreants and the helper, driver, above noted person namely Joydeb Misra along with others are involved in the commission of the said crime.

Accordingly, I have seized the stone chips loaded said truck having Chassis No- MAT466420E1B02948, Engine No- 41B63363796 and the original number plate of the said truck which was kept separately inside the cabin of the driver of the said truck. I have also arrested the suspected accused namely Binod Singh @ Anil [M/34 yrs] S/O-Lt. Delka Singh of Vill- Petapura, P.S-Narayangarh, Dist-Paschim Medinipur.

So, I pray before you to lodge a specific case against the person under proper section of law as a thorough investigation into this matter is highly required.
