Sub: - Complaint as suomoto.

Sir.

In producing herewith, the arrested accused namely Uttam Bauri (aged 37yrs.), S/o. Lt. Gopal Bauri of village Bankdaha, P.S. Gangajalghanti Dist. Bankura and seized articles one country made improvised pipe gun (iron made fitted with wooden butt, body, barrel, firing pin trigger etc. total length about 8 inch) loaded with 1 (one) round of live .303 ammunition. I A.S.I. Shib Sankar Chatterjee lodged a suo-moto complaint to the effect that today (20.01.2021) at 06:30hrs. on course of my mobile duty received a source information that a person was moving suspiciously near Manohar bus stoppage and he is possessing illegal Arms and Ammunition with him. I immediately informed the matter to I.C Barjora P.S. and as per his direction I along with force had been to Manohar Bus stoppage to work out the source information. On arrived there at 07:05 hrs. I found one person is moving suspiciously near Manohar Bus stoppage. Seeing police force he tried to flee away but he fell down on the road, as a result he received injuries on his person and both legs. Then I intercepted him and I asked him to search my team but he denied. On interrogation he disclosed his identity as noted above. I then searched the detained person and recovered one country made improvised pipe gun loaded with 01 (one) round ammunition from his waist I then asked him to produce valid license/documents for possessing the said fire arms and ammunition. On demand he failed to produce any document/ license in support of possessing the said fire arms and ammunition with him and gave different statements at different times, on being further asked he stated that he carried the said arms and ammunition with a view to commit crime at Manohar village with another 02 persons namely Samir Bauri of Manohar, Raju Dhibar of Maliara. I then seized the arms and ammunition after preparing proper seizure list duly signed by him and witnesses and labeled properly then I arrested the above noted accused person issuing memo of arrest and also maintain all legal formalities of N.H.R.C. as he committed an offence u/s Arms Act.

So, I pray that a specific case may kindly be started against the arrested accused person namely Uttam Bauri (aged 37yrs.), S/o. Lt. Gopal Bauri of village Bankdaha P.S. Gangajalghanti, Dist- Bankura and accused Samir Bauri of Manohar, Raju Dhibar of Maliara under proper section of law and to arrange for its investigation.
