In producing here with the arrested person namely Rajesh Mukherjee @ Raja (30Y) S/o- Shantimoy Mukherjee of Natungram, Beliatore, PS- Beliatore, dist:- Bankura along with seized article (1) One plastic Jariken containing approx 18 Ltrs of ID liquor, (2) Nylon bag 3) one glass bottle approx 375 ml. which collected as sample.


On 20.01.2021 I SI Asit Kumar Sal of Beliatore PS along with C/478 Nandalal Paramanik, NVF/ 0314 Haradhan Dutta & NVF/0510 Subhas Mahata left from PS to perform mobile duty at PS area vide GDE no- 615 date- 20.01.2021 and CC no- 139/21 date- 20.01.2021, as per order of O/C Beliatore PS. During my mobile duty at about 18:45 hrs at Bhatpukur more I received secret source information from my reliable source that the arrested persons was carrying illegal ID liquor with a view to sell at near Markha bus stand area. Accordingly, I informed O/C, Beliatore P.S. and as per direction, accompanied by force, left for Markha more area under PS- Beliatore, Dist- Bankura to work out the information.


On 20.01.2021 at about 19:05 hrs I accompanied by force reached Markha more area and as identified by source found that the arrested person came from Markha village side with carrying one nylon bag, while we proceeding towards him, Seeing Police party he tried to fled away but we managed to detain him. I searched his bag in presence of him & local people and found (1) one plastic Jariken containing approx 18 Ltrs of ID liquor. On interrogation it came to learn that the person is carrying this ID liquor with a view to sell it, and he is running this business since long time, I asked him to produce license or valid documents, but he failed to do. I seized the 1) One plastic Jariken containing approx. 18 Ltrs of ID liquor, 2) Nylon Bag & 3) one bottle approx 375 ml which collected as sample from Jariken after arranged one 375 ml glass bottle under proper seizure list and label, duly signed by the witnesses and the arrested person, On several request no one came forward to sign in the seizure list. Accordingly I arrested him after maintain all arrest rules and all guide line of NHRC and apex court.

Under the above circumstance, I request you to start a specific case against the said Rajesh Mukherjee @ Raja (30Y) S/o- Shantimoy Mukherjee of Natungram, Beliatore, PS- Beliatore, dist:- Bankura and arrange for its investigation.
