

Sub: Prayer for lodging FIR against 1. Alamgir Mandal @ Milan (27y), S/o- Imamul Mandal, 2. Raju Mandal, S/o- Safik @ Gobai Mandal, 3. Anisur Mallick, S/o- Sukur Mallick, 4. Ukil Kha, S/o- Hanif Kha all of Beliara, Paschimpara, PS- Bishnupur, Dist- Bankura and 4/5 others unknown miscreants U/S- 399/402 IPC & 25/27 Arms Act.

Sir,

In producing herewith the arrested accused person namely (1) Alamgir Mandal @ Milan (27 yrs), S/o- Imamul Mandal of Beliara, Paschimpara, PS- Bishnupur, Dist- Bankura with following seized articles 1. One improvised one shutter pipe gun loaded with one 0.303" live cartridge 2. One black colour Motor Cycle bearing no- WB88A-9451, 3. One white & blue colour hero Honda passion motor cycle having no number plate, 4. One black colour bajaj CT-100 ES motor cycle having no number plate, 5. One Katari having wooden butt total length approx 25 cm, 6. One rechargeable torches brought under seizure, I SI Ratan Majumder of Bishnupur PS beg to submit a complaint as suo-moto against the above noted arrested accused person and 7/8 other unknown persons who were their associates and fled away during police raid, to the effect that today on 16.01.2021 at 20.15 hours, received a reliable source information about assembling of 8/9 dacoits near the Basvi Industrial Ltd on Bishnupur-Sonamukhi Pitch road, near about 1.5 km away from Bhakat Sing More, PS- Bishnupur, Dist- Bankura which I have noted vide Bishnupur PS GDE No 653, dated 16.01.2021 and informed IC Bishnupur PS, seeking his permission, myself along with Constable 1343/ Uttam Samanta, Constable/445 Rajesh Bauri, C/222 Sital Banerjee left for the Basvi Factory on Bishnupur-Sonamukhi Pitch road to work out the information. (This refers to Bishnupur PS GDE No.654, dated 16.01.2021 and C.C No.203/2021, dated 16.01.2021 at 20:25 hours.)

At about 21:50 hrs we reached near at the Basvi Industrial Ltd beside Bishnupur-Sonamukhi Pitch road, near about 1.5 km away from Bhakat Sing More, PS- Bishnupur, Dist- Bankura. On the way evening mobile officer ASI Sukhendu Panja along with Constable 189 Ananda Mohon Khan C/801 Subhas Kr Dutta assisted me. I like to note here that on way we requested some local people of Shyamsundarpur village to remain with us to help in execution of the information, but no one was agreed. After reaching there from a distance we started observing the area secretly.

We noticed that some persons assembled near the Basvi Industrial Ltd beside Bishnupur-Sonamukhi Pitch road. We challenged them disclosing our identity as police personnel and asked them to remain there, but in spite of obeying our lawful order, they focused torch light over us and recognizing us as police person, they started running raising vocal "Police, Police!" But we could managed to apprehend 1 (One) of them after a hot chase and rest 7/8 managed to flee away. During interrogation, the detained person made different statement in different time regarding their assembly at that time and place. Ultimately he disclosed his identity as Alamgir Mandal @ Milan (27 yrs), S/o- Imamul Mandal of Beliara, Paschimpara,

PS- Bishnupur, Dist- Bankura. He also disclose the name of his some others associate as 1. Raju Mandal, S/o- Safik @ Gobai Mandal, 2. Anisur Mallick, S/o- Sukur Mallick, 3. Ukil Kha, S/o- Hanif Kha all of vill Bellara, Paschimpara, PS- Bishnupur, Dist- Bankura. During search, I found one Improvised one shutter pipe gun loaded with one 0.303" live cartridge which was kept concealed in the right side of waist under full pant tighten with belt of Alamgir Mandal @ Milan (27 yrs), S/o- Imamul Mandal of Bellara. I demanded him to produce valid license/document for the arms and ammunition, but he failed. I also searched the place of assembly methodically and minutely and accordingly seized three motor cycles, some other articles like; one Katari having wooden butt approx length 25 cm, one re-chargeable troche from the PO under proper seizure list. During interrogation, arrested accused person confessed that they gathered there to commit dacoity. I arrested the accused person and took him in custody maintaining all formalities.

Hence I pray a case U/S- 399/402 IPC & 25/27 Arms Act may kindly be started against following persons- 1. Alamgir Mandal @ Milan (27y), S/o- Imamul Mandal, 2. Raju Mandal, S/o- Safik @ Gobai Mandal, 3. Anisur Mallick, S/o- Sukur Mallick, 4. Ukil Kha, S/o- Hanif Kha all of Bellara, Paschimpara, PS- Bishnupur, Dist- Bankura and 4/5 others unknown miscreants.
