Sir,

In producing herewith with the arrested accused person namely Tarapada Ruidas (56 yrs) s/o Lt. Atul Ruidas of vill. Lokpur Bazar , PS Joypur. Dist.Bankura along with seized articles as per seizure list I beg to submit that on 13.01.2021 at 16.35 hrs during my patrolling duty at Joypur PS area vide CC no. 201/2021 dtd. 13, 01.2021, received secret information from my source that, one Tarapada Ruidas (56 yrs) s/o Lt. Atul Ruidas of vill. Lokpur Bazar , , PS Joypur. Dist.Bankura is illegally selling Id liquor in his own house at Lokpur Bazar under Joypur PS. immediately myself along with C/591 Sadhan Chandra Mandal , NVF/0330 Lakshmikanta Nayek rushed to the spot to work out the information. When we reached in the house of the accd. Person at Vill. Lokpur Bazar and noticed that the said person is selling ID Liquor there in exchange of money to some people who fled away, as soon as we reached there. There after we asked him to produce any valid document in respect of selling of such ID liquor but he failed either to produce any valid document or to give any proper account. As such I searched the house and found Approx 20 ltrs ID liquor containing in two plastic jaricans 10 ltrs each at his house. Accordingly, I seized the said articles under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and accused person. As the said Tarapada Ruidas has committed an offence which attracts sec. 46(A) of Bengal Excise Act 1909 and I arrested him under proper memo of arrest after maintaining all sorts of norms and guidelines regarding arrest.

Therefore, I pray that necessary steps may kindly be taken against accused Tarapada Ruidas (56 yrs) s/o Lt. Atul Ruidas of vill. Lokpur Bazar ,PS.Joypur. Dist.Bankura, PS Joypur. Dist.Bankura under proper section of law.
