Sir,

In producing herewith arrested accused persons namely 1) Sudip @ Sourav Mondal (20yrs) S/O-Lt.Akkur Mondal of Dhanara P.S-Raipur, Dist-Bankura, 2) Bappa Pratihar (27yrs) S/O-Lt.Biswanath Pratihar of Nayagram, P.S-Binpur Dist-Jharagram along with seized articles one black colour rubber tube containing approx.30 litres ID Liquor, and 15 (fiteen) pcs plastic glass and seizure list. I SI,Atanu Chakraborty of Raipur P.S. do here by lodge complain to the effect that today on 19.01.2021 at 21.45 hrs during my RT mobile duty I received a source information that two persons is selling I.D. Liquor at Dhanara village near pond under Raipur PS. and diarized the fact vide Raipur PS GDE No.656 Dt.19.01.2021. Then I informed I/C Raipur PS and as per his order myself along with accompanying force namely C/903 Kalyan Prasad Pati, C/1077 Srimanta Bhattachajee, NVF Tushar Mahata vide Raipur ps CC no 121/2021 date 19.01.2021 and held raid at Dhanara village PS - Raipur, as shown by my source. I found that two persons were selling I.D. liquor in one black colour rubber tube to their customer in lieu of money at Dhanara village. I all on a sudden, apprehended them and recovered one black colour rubber tube containing approx.30 litres ID Liquor, and 15 (fiteen) pcs plastic glass from their exclusive possession. On interrogation they disclosed their identity. On demand they failed to produce any license or valid documents in support of their possession of the said ID Liquor. Accordingly I seized the said ID Liquor under a proper seizure list in presence of accompanying police personnel as no local person came forward to be witness. The seizure was made in between 22.35 hrs to 22.55 hrs. I took out 375 ml. of ID Liquor from the said seized black colour tube as sample and labelled it properly. Accordingly I arrested them as they has committed offence U/S 46 (A) B.E. Act after explaining them the ground of arrest after preparing arrest memo.

I along with accuseds namely 1) Sudip @ Sourav Mondal (20yrs) S/O-Lt.Akkur Mondal of Dhanara P.S-Raipur Dist-Bankura,2) Bappa Pratihar (27yrs) S/O-Lt.Biswanath Pratihar of Nayagram, P.S-Binpur, Dist-Jharagram and seized articles left for PS.

I therefore pray that a case U/S 46 (A) Bengal Excise Act 1909 as amended up to date against arrested accused persons namely 1) Sudip @ Sourav Mondal (20yrs) S/O-Lt.Akkur Mondal of Dhanara P.S-Raipur Dist-Bankura, 2)Bappa Pratihar (27yrs) S/O-Lt.Biswanath Pratihar of Nayagram ,P.S-Binpur, Dist-Jharagram may kindly be registered and arrange for investigation of the case.
