Sub:- Prayer to lodge a FIR against driver and owner of vehicle No. WB 67B-6506 as per Law.

Sir,

In producing herewith the seized articles as per enclosed seizure list viz. one 04 wheeler vehicle (Tata 407) bearing registration No. WB 67B-6506 loaded with approx 3 ton coal, I beg to state that I A.S.I Jayanta Mondal along with C/1847 Nirupam Chand, C/16 Mahadev Mahato and NVF/675 Arindam Singha all of Barjora PS, Dist-Bankura were performing highway mobile duty at PS area vide Barjora P.S C.C No. 698/21 dt 13.02.2021. During my duty I received source information that one Tata 407 vehicle bearing registration No WB 67B-6506 loaded with illegal coal, was proceeding from Hat-Asuria side to Gururbad. Accordingly I informed the matter to I.C Barjora PS and as per his direction I along with force left for Gururbad village area to work out the information and reached near Gururbad at 21:05 hrs and found that the above noted vehicle bearing registration no. WB 67B-6506 loaded with Coal was standing at Gururbad, and seeing the police party the driver of said vehicle flee away from the spot Gururbad. During searched I found the said vehicle was loaded with coal approx 3 Ton in vehicle covered by tarpaulin. I searched for claimants of the said vehicle loaded with coal but failed. Accordingly I seized the vehicle (Tata 407) bearing registration No WB 67B-6506 loaded with approx 3 Ton coal from this spot under proper seizure list and approx 02 kgs of coal have taken from the said seized vehicle as sample between 21:30hrs to 21:45hrs.

Therefore, I pray to you that a specific case may kindly be started against the driver and owner of the said vehicle for transporting illegal coal under proper section of law.
