Sir,

In producing here with the arrested person namely Babulal Roy (35 Yrs) S/O Lt. Rabi Roy of Village Kapaseberia, PS- Beliatore, Dist:- Bankura along with seized article (1) One plastic Jariken containing approx 20 Ltrs of ID liquor, 2) one glass bottle approx 375 ml. which collected as sample.

On 06.02.2021 I ASI Tarun Kumar Halder of Beliatore PS along with C/1164 Koilash Murmu, C/1838 Nema Soren & NVF/0247 Sahadev Sardar left from PS to perform mobile duty at PS area vide GDE no- 214 date- 06.02.2021 and CC no- 268/21 date- 06.02.2021, as per order of O/C Beliatore PS. During my mobile duty at about 17:25 hrs at Brindabonpur more I received secret source information from my reliable source that the arrested persons was selling illegal ID liquor in his house at Kapasbera. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for Kapasbera village under PS- Beliatore, Dist- Bankura to work out the information.

On 06.02.2021 at about 17.35 hrs I accompanied by force reached Kapasbera village in the house of Babulal Roy (35 Yrs) S/O Lt. Rabi Roy and we searched his house and found (1) one plastic Jariken containing approx. 20 Ltrs of ID liquor. On interrogation it came to learn that the person sell it since long time, I asked him to produce license or valid documents, but he failed to do. I seized the 1) One plastic Jariken containing approx. 20 Ltrs of ID liquor, 2) one bottle approx 375 ml which collected as sample from Jariken after arranged one 375 ml glass bottle under proper seizure list and label, duly signed by the witnesses and the arrested person, On several request no one came forward to sign in the seizure list. Accordingly I arrested him after maintain all arrest rules and all guide line of NHRC and apex court.

Under the above circumstance, I request you to start a specific case against the said Babulal Roy (35 Yrs) S/O Lt. Rabi Roy of Village Kapasbera, PS- Beliatore, Dist:- Bankura and arrange for its investigation.
