He had also done many physical and mental torture to me in past. I had also done complain to The Commandant of 106 BN. RAF and 169 BN. C.R.P.F. on 05/08/2020 and 19/12/2020 respectively.

I shall be highly obliged to you if you lodge an F.I.R. and take legal action against them.





Subject: Complain Against Constable Dhritiman Ghosh of 106 BN. RAF

Sir,

With Due Respect I am Tanusree Ghosh, Wife of F/No 971233638 Late HC / GD Ajit Kumar Ghosh 169 BN.CRPF . My husband passed away on 04th February 2019 in a road accident on duty. I want to complain against my brother Constable Dhritiman Ghosh of 106 BN.RAF that my brother harassed and tortured me a lot after the demise of my husband .

1. He used to abuse me and my son during my son's class 10th board exam by telling "Your husband dies because of your ego" , "You are very bad women that's why your husband dies" and may other thing to blackmail me and to take my money and property and make us mentally weak. Even he was not allowing my son to study during his board exam by playing music very loudly.
2. He forcefully took Rs. 80,000/- cash and Rs. 2.00 Lakhs through bank by forcing me to sign on my cheque.
3. He destroyed my husband's Insurance documents when I told him to leave my house.
4. Now he is sending his father to our family friend's house and my husband's brother's house to abuse them by telling them " You are trying to take advantage of my daughter". Even they are spreading rumour like I am a characterless woman , My husband was a characterless Person, He has done suicide because of me , etc , in order to pressurize me and isolate me from my friends and relatives.
5. Recently, about one month ago , one person was returning Rs. 3,50,000/- to me which he has taken from my husband. But my brother stopped him by telling him that I am mentally sick and my in-laws are taking advantage of me.

Sir, my son have life threat from my brother. He can do anything for some financial gain.

I shall be highly obliged if you control your employee and take necessary steps against him.
