Sir,

In producing here with the arrested person namely Rakhahari Bauri (35Y) S/O- Lt Pannu Bauri of Village- Kantaboni, PS- Beliatore, Dist:- Bankura along with seized article (1) One plastic Jariken containing approx. 18 Ltrs of ID liquor, 2) one glass bottle approx. 375 ml. of Id liquor collected as sample from the Jariken 3) 07 (seven) bottle of country sprit styled as CAPTAIN, MRP- 100/- each 4) One bottle of Country sprit styled as CAPTAIN MRP- 100/- which collected as sample.

On 16.02.2021 I ASI Dilip Kumar Singha Roy of Beliatore PS along with LC/1330 Srikanya Dey Mondal, C/1389 Dipak Bauri & NVF/0161 Raju Bauri left from PS to perform spl mobile duty at PS area vide GDE no- 632 date- 16.02.2021 and CC no- 350/21 date- 16.02.2021, as per order of O/C Beliatore PS. During my mobile duty at about 17:45 hrs at Kantaboni village I received secret source information from my reliable source that the arrested persons was selling illegal ID liquor in his house at Kantaboni. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for the house of the accd person at Kantaboni village under PS- Beliatore, Dist- Bankura to work out the information.

On 16.02.2021 at about 17:55 hrs I accompanied by force reached in the house of Rakhahari Bauri (35Y) S/O- Lt Pannu Bauri at Village- Kantaboni, PS- Beliatore, Dist:- Bankura and we searched his house and found (1) one plastic Jariken containing approx. 18 Ltrs of ID liquor and (2) 07 bottle of ID liquor styled as CAPTAIN, MRP 100/- RS each. On interrogation it came to learn that the person sell it since long time, I asked him to produce license or valid documents, but he failed to do. I seized the 1) One plastic Jariken containing approx. 20 Ltrs of ID liquor, 2) one glass bottle approx 375 ml which collected as sample from Jariken after arranged one 375 ml bottle, 3) 07 (seven) bottle of country sprit styled as CAPTAIN, MRP- 100/- each 4) One bottle of Country sprit styled as CAPTAIN MRP- 100/- under proper seizure list and label, duly signed by the witnesses and the arrested person, On several request no one came forward to sign in the seizure list. Accordingly I arrested him after maintain all arrest rules and all guide line of NHRC and apex court.


