Sub: Prayer for lodging FIR against Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahanta of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura.

Sir,

In producing herewith the arrested accused person namely Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura along with seized article (1) 25 bottle of Bullet country sprit, measure 600 ml each, (2) one bottle of Bullet country sprit, measure 600 ml collected as sample from there and duly sealed and labeled by me, I ASI Sisir Mahato of Radhanagar OP under Bishnupur PS do here by lodge complaint against one Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura to the effect that on 10.02.2021 at about 17.15 hrs received secret information over telephone that illegal manufacturing and sale of ID liquor is going on at the house of Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura. [This ref. to Radhanagar O.P G.D.E. no- 244, Dt.- 10.02.2021] Accordingly as per order of I/C, Radhanagar OP, I accompanied by force namely C/416 Swapan Kr Santra, C/308 Monoj Mishra left for Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura to work out the information.

On 10.02.2021 at about 18.05 hrs I accompanied by force reached near the house of Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura. While proceeding to his house as identified by the local people, Seeing Police some persons who were sitting in the court yard of his house and taking liquor started to flee away. We chased behind them. But all of them except manufacturer Subash Mahanta managed to escape from there. I called some disinterested persons. In presence of some villagers and police personnel in between 18.05 hrs to 18.25 hrs searched the house from where those persons fled away and found (1) 25 bottle of Bullet country sprit, measure 600 ml each, (2) one bottle of Bullet country sprit, measure 600 ml collected as sample from there. On local enquiry I came to learn that the owner of that house is Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura. He has been manufacturing and selling liquor illegally from his house and he is running this illegal business since long. I arrange to collect one bottle of Bullet country sprit, measure 600 ml as sample from there and sealed, labeled, and seized the same in presence of the accused and police witnesses namely C/416 Swapan Kr Santra, C/308 Monoj Mishra of Radhanagar OP, Dist- Bankura both of Bishnupur PS under proper seizure list duly signed by them. On several request no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 18.25 hrs to 18.35 hrs duly Signed by the Police person.

On the spot on being search and ask neither the accused nor any one in favour of him came forward and produce any valid license against his illegal manufacture and sale of ID liquor. The approximate value of the article seized is Rs 2500/- only.

Under the above circumstance, I request you to start a specific case against the said Subash Mahanta (38 yrs), S/o- Lt Ganesh Mahant of Vill- Hingjuri, Uliara GP, PS- Bishnupur, Dist- Bankura and arrange for its investigation.
