Sub: Prayer for lodging FIR against Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura.

Sir,

In producing herewith the arrested accused person namely Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura along with seized article (1) 28 bottle of Bullet country sprit, measure 600 ml each, (2) one bottle of Bullet country sprit, measure 600 ml collected as sample from there and duly sealed and labeled by me, I ASI Nirmal Satpathi of Bishnupur PS do here by lodge complaint against one Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura to the effect that on 16.02.2021 at about 17.45 hrs received secret information over telephone that illegal manufacturing and sale of ID liquor is going on at the house of Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura. (This ref. to Bishnupur PS G.D.E. no- 732, Dt.- 16.02.2021). Accordingly as per order of I/C, Bishnupur PS, I accompanied by force namely C/408 Goutam Mandal, C/445 Rajesh Bauri left for Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura to work out the information. (This ref. to Bishnupur PS G.D.E. no- 733, Dt.- 16.02.2021)

On 16.02.2021 at about 18.15 hrs I accompanied by force reached near the house of Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura. While proceeding to his house as identified by the local people, Seeing Police some persons who were sitting in the court yard of his house and taking liquor started to flee away. We chased behind them. But all of them except manufacturer Balaram Lohar managed to escape from there. I called some disinterested persons. In presence of some villagers and police personnel in between 18.25 hrs to 18.45 hrs searched the house from where those persons fled away and found (1) 28 bottle of Bullet country sprit, measure 600 ml each, (2) one bottle of Bullet country sprit, measure 600 ml collected as sample from there. On local enquiry I came to learn that the owner of that house is Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura. He has been manufacturing and selling liquor illegally from his house and he is running this illegal business since long. I arrange to collect one bottle of Bullet country sprit, measure 600 ml as sample from there and sealed; labeled, and seized the same in presence of the accused and police witnesses namely C/408 Goutam Mandal, C/445 Rajesh Bauri of Bishnupur PS, Dist- Bankura under proper seizure list duly signed by them. On several request no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 18.45 hrs to 18.55 hrs duly signed by the Police person.

On the spot on being search and ask neither the accused nor any one in favour of him came forward, and produce any valid license against his illegal manufacture and sale of ID liquor. The approximate value of the article seized is Rs 2800/- only.

Under the above circumstance, I request you to start a specific case against the said Balaram Lohar (35 yrs), S/o- Haru Lohar of Vill- Bandhgaba, Belsulia GP, PS- Bishnupur, Dist- Bankura and arrange for its investigation.
