Sub- Prayer for lodging FIR against Khera Mallick @ Gera (M/31Yrs), S/O- Inshu Mallick @ Habla of Vill- Laubagan, Morar GP, PS-Bishnupur, Dist- Bankura U/S- 25/27 Arms Act.

Sir,

In producing here with the arrested accused person namely Khera Mallick @ Gera (M/31Yrs), S/O- Inshu Mallick @ Habla of Vill- Laubagan, Morar GP, PS-Bishnupur, Dist- Bankura along with the seized fire arms i.e one Country made one shutter pipe gun, total length approx. 23 cm and butt length approx 08 cm having functional trigger and one round 0.303" live cartridge. I ASI Sukhendu Panja of Bishnupur PS beg to submit a complaint as suo-moto against the above noted accused person to the effect that today on 19.02.2021 at about 21.55 hrs received a credible source information that one Khera Mallick @ Gera (M/31Yrs), S/O- Inshu Mallick @ Habla of Vill- Laubagan, Morar GP, PS-Bishnupur, Dist- Bankura left Laubagan village towards Bishnupur via Morar more with one fire arms and moving suspiciously to commit any crime which I noted vide Bishnupur PS GDE No- 893, Dated- 19.02.2021 and informed I/C Bishnupur PS, after seeking his permission, myself along with Constable 269/ Uttam Mandal, Constable 168/ Gouranga Patra left for Morar more to work out the information (This refers to Bishnupur PS GDE No 895, dt- 19.02.2021 and C.C No- 676/2021, dated- 19.02.2021).

At about 22.20 hrs we reached near Morar 1 no camp. On the way night mobile officer ASI Ranjit Pain along with Constable 1160 Pradip Das and Constable 178 Kartick Ch Mandal and C/1776 Santinath Dey assist me. I like to note here that on way we requested some local people of Morar village to remain with us to help in execution of the information, but no one was agreed. After reaching there from a distance we started observing the area secretly.

At about 22:45 hrs we found that one person is coming towards us. We allowed preceding him and when he closed to us we surround him and found him of same description i.e. as per our secret information. We challenged him disclosing our identity as police personnel and asked him to remain there, but in spite of obeying our lawful order he started to flee away. After a hot chase we manage to apprehend him. During interrogation, the detained person made different statement in different time. Ultimately he disclosed his identity as Khera Mallick @ Gera (M/31Yrs), S/O- Inshu Mallick @ Habla of Vill- Laubagan Morar GP, PS-Bishnupur, Dist- Bankura. I searched him properly and found one "one shutter country made pipe gun having wooden butt and functional trigger loaded with one round 0.303" live cartridge" from his left waist under full pant tighten with belt.

I asked him to produce valid license/document for the arms and ammunition, but he failed and not able to give any satisfactory answer. I interrogated him and during interrogation he confessed that he used to commit dacoity, robbery with this fire Arms. Accordingly, I seized the said "one shutter country made pipe gun with one round 0.303" live cartridge" under proper seizure list duly signed by the witnesses. The seizure was made in between 23.05 hrs to 23.15 hrs. I arrested the accused person and took him in custody maintaining all legal formalities of NHRC guideline.

Therefore, I pray before you that one specific case may kindly be started against the arrested accused person namely Khera Mallick @ Gera (M/31Yrs), S/O- Inshu Mallick @ Habla of Vill- Laubagan, Morar GP, PS-Bishnupur, Dist- Bankura.
