Sir, I Dilip Pado Das, Age 71 yrs s/o Bhowtaran Das, vill 380-Radha Nagar, P.S. Balidih, Dist. Bokaro (Jharkhand) do hereby lodge a written complain to the effect that one of my son-in-law namely Pusan Chandra Ghosh Age-36 yrs s/o Late Kishna Chandra Ghosh of village-Shalimar Near Shiv Mandir, P.O. Jealgora, P.S. Jorapokhar Dist. Dhanbad (Jharkhand) was a Helper in a Truck No-JH10BE-9542 who was coming to driven by Driver with loaded truck on 19/02/2021 at 01.30 a.m. when his truck reached at Choubeta More on N.H. 80 under your P.S. Jurisdiction and dashed to back side of another parked loaded truck on middle of the Road having Regn. No. WB33D-7166. Resulting to Driver and my son-in-law received serious injury on their person. Immediately Police with help of local public shifted them to Bishnupur District Hospital. The attending M.O. referred them to B.S.M.C.H. Bankura. But due to my ill luck my son-in-law scammed his injury on the way to Medical College and again returned back to Bishnupur District Hospital. where he was declared death. Over this Bishnupur P.S. U.D. case No-24/21 dt-19/02/2021 was recorded.

The entire fact in issue was disclosed by deceased namely Pusan Chandra Ghosh, when he was alive. This is also noted that the motor accident has been occurred due to parking negligently on the middle of the Road during night hours without any stop signal. So that the incident was happened. Under this a lawful action may kindly be taken against accused Driver of Truck No. WB33D-7166. In this incident both involved vehicle were badly damaged. I send over to complainant who agreed with details of injured Driver/Deceased
