I Mrs. Swagata Chakrabarty, W/o Mr Subhro Bhattacharjee, is the Manager of Punjab National Bank, Ramsagar Branch, at Ramsagar , Bankura beside the National Highway 60.

On 11.03.2021, at 9.30 hrs during daily check of ATM observed that some unknown miscreant has broken the ATM outer cover and dynamic lock and tried to open the cash vault last night (i.e After Business dayend of Branch on Dt:10-03-2021)

Our preliminary observation: - it was observed that attempt of burglary was unsuccessful as the cash vault was locked. They had destroyed CCTV system too.

In view of the above your good office is requested to lodge FIR against the unknown miscreant and carry out further investigation.
