Sub:- Prayer for lodging FIR against accused Gorachand Besra(55 Yrs.) s/o Late Daroga Besra of vill- Dhanghori, P.O- Puipal, P.S-Simlapal, Dist. Bankura.

Respected Sir,

In producing herewith seized article i.e. 20 (twenty) liters I.D. liquor in a plastic container (Juricane), 1 Earthen distillatory Apparatus and do hereby submit complaint against accused Gorachand Besra(55 Yrs.) s/o Late Daroga Besra of vill- Dhanghori, P.O-Puipal, P.S-Simlapal, Dist. Bankura.

I beg to state that on 17/03/2021 at about 10:45 hrs according to source information and as per instruction of you (I.C Simlapal P.S.) after contacting with F.S.T. Civil team, I along with force and F.S.T. Civil team with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. left PS to hold search and raid at the house of Gorachand Besra. I along with F.S.T. Civil team reached there at about 11:15 Hrs met with source. As shown by the source I located the house. We tried to get witnesses but no one turned up. In the mean time, seeing us, i.e., police persons, 01 person from the house fled away as identified by the accompanied Village Police as the owner of the house. We called if there is any other in the house but found none.

I found the house was mud built, there is a one side open shed having clay made burning place (CHULA), 03 numbers of tin, Fermented Wash, Earthen Apparatus one Juricane etc.

I seized the articles as ALAMAT under proper Seizure List in between 12:15 Hrs and 12:45 hrs there from as follows as well as sealed and leveled accordingly:

- i. 01 Juricane containing liquid approximately 20 litres appearing to have been Illicit Liquor, 01 bottle containing 600 M.L. approx taken out of the above as sample packed, labeled and sealed with sealing wax and
 - ii. 01 Earthen distillatory Apparatus.

I destroyed articles there as follows:

- i. Molasses with 1 Tin-container of 15 kg approximately
- ii. Fermented Wash with 03 tin-container of 45 kg approximately. I tried to find out the owners of the house as named above, but could not trace out.

Since, the I.D. liquor and other related articles was found in the premises of her house, it can be said beyond doubt that I.D. liquor was getting prepared there illegally, I pray before you to start a case under proper section of law against accused Gorachand Besra(55 Yrs.) s/o Late Daroga Besra of vill- Dhanghori, P.O- Puipal, P.S-Simlapal, Dist. Bankura and arrange for its investigation.
