Sir,

I am residing at village: Raniara, P.O.;-Vedua,
P.S.; Simlapal, Dist:- Bankura, under your jurisdiction. My
dwelling house is on Dag no 788/1052, Khatra no; 393 and
JL NO 132 of Raniara Mouza, leaving a portion of land ~~of our~~
behind the dwelling house as vacant. One Mr. Arun Sarkar, s/o late Bibhuti
Bhusan Sarkar of village: Raniara, P.O.; Vedua, P.S.;-Simlapal
and Sourav Sarkar s/o Mr. Arun Sarkar of the said address
is trying to occupy the land forcibly. Few months ago he has
built a thatch on my vacate land. then and there I informed
You (Copy attached), B.L.R.O Simlapal and Anchal Pradhan
Mandalgram, Gram Panchayet requesting to take necessary steps
but till date no action has been taken.

Now Mr Arun Sarkar has arranged to build a Pucca
Construction and for this Purpose he has started digging work
at the aforesaid land. To day (27/3/21) ^{at about 11.00 AM} I requested him to stop the
illegal digging work till the owner of the land is finalized.
As soon as I communicated the Message Mr. Arun Sarkar and his
Son Sourav Sarkar attacked me and tried to assault me
Physically. They ~~turned up with iron rod and Sabal with their~~
~~hands, and~~ stated "we shall kill you and then will go to jail".
Ladies, like his wife and his daughter-in-law started to abuse
in a filthy languages.

Further, it is stated here that ~~he took~~ a Sabal (for
digging the Soil) and other necessary materials (Tin plate, wood, wire)
to make a barricade just at the entry and the exit Point of ~~the~~
our dwelling house. Under the circumstances I Pray to you that
Kindly look into the matter and take necessary steps to stop
the illegal Construction and legal action against the aggressive
attitude So that we can live peacefully and ~~also~~ save our life.
