I, SI Sanjoy Kr. Mondal of Khatra PS, beg to state that today (28.04.21) as per order of I/C Khatra PS, I along with PSI Koushik Choubey, C/1257 Kartick Murmu, C/999 Bikash Ruidas left PS at 07.45 hrs vide Khatra PS GDE No. 862 Dt. 28.04.21 & vide Khatra PS CC no. 1008/21 dt. 28.04.21 for special drive against violation of norms regarding wearing mask and social distancing for combating the spread of Covid-19. It is also to be mentioned here that announcement is being going on throughout the Khatra PS area i.e Bhardiha, Kharban, Supur Bazar, and all GPs since few days ago under PS Khatra regarding the awareness of the above mentioned order to the all general public.

During my Special Drive Duty while I was passing through Supur More under PS Khatra, Dist Bankura, found the following persons are moving around the road without wearing any mask, and not maintain social distancing rules of hand sanitization of hand sanitization splitting in open place with taking gutka, pan etc violating the order of the Government, nothing result of awareness, as such causing negligent act likely to spread infection of disease dangerous to life and malignant act to spread infection of disease like Covid-19 and also violated the Rule of National Disaster Management Act.2005. During interrogation they failed to produce any cause regarding their negligent act and give their identity as:-

During interrogation they failed to give any plausible explanation in regards to such act.

It has come out that they have no such emergency or cause for violation of Government order or to do such negligent act. Hence they are violated law/regulatory orders related to Covid-19. Accordingly I arrested them after observing all legal formalities and said them ground of arrest. Then I along with arrested persons and force return to PS.

Under the above fact and circumstances I request you to lodge a specific case against the above noted persons U/S-269/270/34 IPC and 51(1)(b) of the National Disaster Management Act.2005 and arrange for its investigation.
