Sub: - Complaint to lodge a FIR.

Sir,

With due respect I ASI Ranjit Kr. Paine (54yrs) of Bishnupur PS in producing herewith one arrested accd. Person namely Chanchal Guha (53 yrs) S/o Lt. Rajeshwar Guha of Dalmadal Road, PS Bishnupur, Dist Bankura and beg to state that today on 12.05.21 while myself along with force was conducting day mobile duty in town area vide Bishnupur PS CC No 1476/21 dt. 12.05.21, at around 12.55 hrs I have received one telephonic information from ASI Tapas Dey, Duty officer of Bishnupur PS that SDPO Bishnupur is camping at Rasik ganj bus stand, given order in PS telephone that the Day mobile van must report to him in the said spot immediately. Accordingly with in few minutes I rushed to the spot and reported to SDPO Bishnupur in front of Deb Otho Surgical shop and thereafter in between 13.05 hrs to 13.25 hrs being accompanied by SDPO Bishnupur visited the said shop and found that the arrested business man selling one oximeter which is one of the commodity falls under the purview of disaster management Act to one customer namely Bidyut Bannerji s/o Bishwajit Bannerji of Tilbart, Bishnupur in lieu of Rs 2000/- which is higher than its normal selling price of Rs.-1800/- comprises to other medical shops. So, the above noted owner caught red handed while selling the articles in higher price and by doing the same he cheat his customers and there by violating the Govt. Order errantly in this pandemic situation of Covid19. As such I have seized & sealed as well as labelled the involved pulse Oximeter having black and white in colour & styled as "care touch finger pulse Oximeter" under proper seizure list duly signed by the accd. Person and other witnesses. Subsequently I arrested the said owner cum seller Chanchal Guha by observing all the guideline of the apex court and NHRC. The whole exercise was done in presence and direct supervision of SDPO Bishnupur. Thereafter as per order I brought the accd with seized article at PS and do hereby lodge this complaint.

Therefore I pray a specific case may kindly be register against him under appropriate section of Law as you deem fit.


