Sir,

In producing here with the arrested person namely Sagar Das Bauri (32Y) S/O- Fatik Das Bauri of Beliatore, Paschim Para, A/P- Beliatore Near Radhabazer, PS- Beliatore, Dist:- Bankura along with seized article (1) Two pics alumimun made Handi, 2) One Plastic pipe approx. 1.5 ft. 3) One plastic Jariken containing 19 ltrs. of ID liquor & 4) One glass bottle of 375 ml containing ID liquor, which collected from the seized Jariken which collected as sample.


On 19.06.2021 I PSI Manas Majee of Beliatore PS along with C/1164 Kailash Murmu & C/1494 Rajib Kumar Singh, NVF- 0314 Haradhan Dutta left from PS to perform mobile duty at PS area vide GDE no- 678 date- 19.06.2021 and CC no- 993/21 date- 19.06.2021, as per order of O/C Beliatore PS. During my mobile duty at about 11:45 hrs, I received secret source information from my reliable source that the arrested persons was making illegal ID liquor in his house at Beliatore near Radhabazer. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for the house of the accd person at Beliatore near Radhabazer under PS- Beliatore, Dist- Bankura to work out the information.

On 19.06.2021 at about 12:15 hrs I accompanied by force reached in the house of Sagar Das Bauri (32Y) S/O- Fatik Das Bauri of Beliatore, Paschim Para, PS- Beliatore, Dist:- Bankura and we searched his house and found that the accd person unlawfully manufacture ID liquor, by using various Aluminum pot (HANDI) with other accessories. I along with force destroyed the processing set up and seized the making articles under proper seizure list, I also found a plastic jariken containing approx. 19 Ltrs of ID liquor which I also seized. On interrogation it came to learn that the person making the ID liquor for sell it continued since long time, I asked him to produce license or valid documents, but he failed to do. I seized the 1) Two pics alumimun made Handi, 2) One Plastic pipe approx. 1.5 ft. 3) One plastic Jariken containing 19 ltrs. of ID liquor & 4) One glass bottle of 375 ml containing ID liquor, which collected from the seized Jariken under proper seizure list and label, duly singed by the witnesses and the arrested person, On several request no one came forward to sign in the seizure list. Accordingly I arrested him after maintain all arrest rules and all guide line of NHRC and Apex court.


