In producing here with the arrested person namely 1) Haradhan Singha (42Y) S/O- Lt Anil Singha of Dhaldanga, 2) Dhananjoy Bauri (55Y) S/o- Kalipada Bauri of Dhangchowlia, & 3) Bikash Ghosh (45Y) S/O- Lt Balaram Ghosh of Nityanandapur all under PS- Beliatore, Dist:- Bankura along with seized article 1) 11 bottle of country sprit Styled as "CAPTAIN" – 600 ml each and each price- 100/-, total value- 1100/- and 2) approx. 21 ltrs of ID liquor in three plastic jariken, 3) One bottle one country sprit taken from SI no- 1 and 4) One glass bottle of 375 ml containing ID liquor, which collected from the seized Jarikens, 5) Two bi-cycle.

On 26.06.2021 I ASI Dilip Kumar Singha Roy of Beliatore PS along with C/1768 Kishan Midya , NVF/0161 Raju Bauri, NVF/0667 Sumanta Gorai left from PS to perform mobile duty at PS area vide GDE no- 952 date- 26.06.2021 and CC no- 1042/21 date- 26.06.2021, as per order of O/C Beliatore PS. During my mobile duty at about 17:45 hrs, I received secret source information from my reliable source that the arrested persons selling illegal ID liquor at Kankarchal Jungle near Nityanandapur village. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for said place to work out the information.

On 26.06.2021 at about 18:15 hrs I accompanied by force reached at Kankarchal Jungle near Nityanandapur village and found that said three arrested persons were selling ID liquor illegally in open field, after seeing police party they try to run away, but we managed to detained them and after detained I found that they have 11 bottle of country sprit Styled as "CAPTAIN" – 600 ml each and each price- 100/- and approx. 21 ltrs of ID liquor in three plastic jariken. On interrogation it could be learnt that they jointly sell the ID liquor, since long. I asked to produce for any valid documents in respect of stock or selling of this ID liquor, but they unable to show any permission, or any documents. Accordingly I arrested them after maintain all legal formalities and seized 1) 11 bottle of country sprit Styled as "CAPTAIN" – 600 ml each and each price- 100/- and 2) approx. 21 ltrs of ID liquor in three plastic jariken, I also collected sample from those two seized articles under proper seizure list as follows:- 3) One bottle one country sprit taken from SI no- 1 and 4) One glass bottle of 375 ml containing ID liquor, which collected from the seized Jarikens and 5) Two By-Cycle under proper seizure list and label, duly singed by the witnesses and the arrested person,

Under the above circumstance, I request you to start a specific case against the said 1) Haradhan Singha (42Y) S/O- Lt Anil Singha of Dhaldanga, 2) Dhananjoy Bauri (55Y) S/o- Kalipada Bauri of Dhangchowlia, & 3) Bikash Ghosh (45Y) S/O- Lt Balaram Ghosh of Nityanandapur all under PS- Beliatore, Dist:- Bankura and arrange for its investigation.
