Sub- Prayer for lodging FIR

Sir,

With due most respect I ASI Sisir Kumar Mahata of Radhanagar Out Post, PS- Bishnupur, Dist- Bankura do hereby lodging a written complaint to the effect that on today 30.05.21 at 03.40 hrs myself being accompanied with SI Suvam Roy Choudhury in-Charge of Radhanagar Out Post, PS- Bishnupur, Dist- Bankura left for Belara Village to work out an information received from Const- 728 Taraknath Roy Belara camp in charge regarding pelting of bricks & hurling of bombs just in front of existing Police camp established at Belara Pry School, Belara, so that a serious breach of peace were apprehending by them. I also communicated the entire incident to I/C Bishnupur PS and other superiors offices through mobile phone with a request for arranging Police Team to deploy at Belara village to avert any untoward incident. (This refers to Radhanagar OP GDE No-579 dated- 30.05.21)

Then and there myself along with force arrived at the spot at 03.55 hrs and found that 40-50 local villagers in furious and aggressive mood assembled there with deadly weapons roaming around the camp and other residential houses of the villagers and pelting bricks & hurling of bombs, and damaging asbestos & Tin sheds etc. The police party give warning and order to disperse them but the furious mob don't responding the police order lawfully given. Not only that during present COVID-19 Pandemic situation non could of them wear Mask as well as unlawfully assembled by violating the Govt norms of Lock-down. Immediately police party began to resist them, when they fill police action they get furious and started hurling of bombs by aiming towards Police Party and upon the police camp. Then and there Police in action and arrested the following accused persons from the spot. 1) Rustam Ali Khan (49) S/O Sukur Md Khan of Vill- Prokash Ghat, PS- Bishnupur Bankura 2) Ganesh Mukherjee (55) S/O Lt. Narayan Mukherjee of Muninagar PS- Bishnupur, Bankura 3) Sk Daud (32) S/O Sk Baber Ali of Vill- Belara PS- Bishnupur Bankura 4) Ali Mondal (56) S/O Lt Jalim Mondal of DO 5) Sk Noor Alam (25) S/O Sk Manjur of vill- Yelhat PS- Bishnupur Bankura 6) Badrul Alam Mondal (43) S/O Abdari Mondal of DO 7) Sk Titu (30) S/O Lt. Sk Nizam of DO. Search out the place of incident and seized the following items being shown and identified by the witnesses and the arrested accused persons under proper seizure list which are noted below-

- i) 4 number of exploded crude Bombs with jute remittance
- ii) 4 pieces of broken bricks & some jute thread with explosive smell and a small piece of metal splinters.

After that any how police would able to control the assembled mob and held raid with arrested accused person in several houses on leading statements of arrested accused person Ali Mondal (56) S/O Lt Jalim Mondal but the following co-accused are not available in their residences - 1) Rahim Mondal S/O Lt Jalim

Search out the residence of accused Rahim Mondal S/O Li Jalim Mondal of Belara and seized the following items being shown and identified by the witnesses and the arrested accused persons under proper seizure list which are noted below-

i) 18 number of live crude Bombs which contents in a wooden Box of dimension of 2.5x3.0 ft

The fact in issue is that, there are 02 groups of the same political party and a long dispute is going on in between them at Uliara Gram Panchayat. Since after the murder of Ex Prohdan of Uliara Gram Panchayat namely Sk Baber Ali @ Bablu S/O Li Sayed Sk of Village- Belara, Dakhinpara PS- Bishnupur, Bankura on 02.08.20 by Salim Palwan S/O Akkash Palwan including husband of present Prohdan with 20 FIR named accused and 30/40 others. (This refers to Bishnupur PS Case no. 78/20, Dt. 02.08.20 U/S - 148/149/323/302/1208 IPC. & 9(b) (ii) E. Act 1884). A Police Camp is continuing in the village since after the incident to resume peace and tranquility in the area. Since the peace has been severely disrupted in the locality and the works of the Gram Panchayat has been delayed. After the bail out of all FIR named accused persons since Dec-20 rival groups tried to enter their respective residences. Today all the FIR named accused persons along with other after making preparation being armed with deadly weapons after making a criminal conspiracy, attacked upon the Belara Police Camp personnel as well as terrorized the entire village by hurling Bombs and attacked to door to door with intension to captured the village by then and followers.

Under the above fact and circumstance I pray before your kindness that a law full action may kindly be taken under proper section of law against all the FIR named accused persons.
