

- (iii) 5 bottle of foreign liquor labeled as "MC DOWELL'S NO-1 CELEBRATION "each of 375 ml
- (iv) 25 Bottle of country sprite labeled as "CAPTAIN" each of 600 ml
- (v) 4 bottles of foreign liquor labeled as "OFFICER CHOICE" each of 180 ml
- (vi) 02 bottle of foreign liquor labeled as "MC DOWELL'S NO-1 WHISKEY" each of 180ml

I SI Subham Roy Chowdhury in charge of Radhanagar OP do hereby submit a suo moto complain to the effect that on 06.06.2021 at about 20:35 hrs received a telephonic information that one Sujit Saha (47yrs) selling liquor at Shalkaki village in his House in lieu of money, this refers to Radhanagar OP GDE NO 132 dated 06.06.2021. After receiving this information I along with ASI Sisir kumar Mahato and force rushed to the spot for working the information out. At around 18.05 HRS myself along with force arrived at the house of the accused person. On seeing police vehicle some people who were gathered near to his house escaped from the area but somehow we managed to apprehend the above named person. After searching his house we found that the accused person has stalked a substantial quantity of foreign liquor at his house On being asked he failed to produce any valid document in respect of selling liquor in exchange of money. As such, I seized the following articles from the possession of Sujit Saha (47yrs) S/O Lt Raman Saha of vill- Shalkaki P.O- Chuamosina, PS-Bishnupur Dist-Bankura in his house. After preparing proper seizure list duly signed by the witnesses and also arrested person, after that Sujit Saha (47yrs) S/O Lt Raman Saha of vill- Shalkaki P.O- Chuamosina, PS-Bishnupur Dist-Bankura. I also prepared labeled of seized articles. Thereafter I arrested him after maintaining all formalities of arrest as per NHRC and apex court.

Hence I pray before your kind honors that a specific case under proper section of law may kindly be started against the above noted accused person
