Sub: Prayer for starting a specific case.

Sir,

In producing herewith one tractor of "JOHNDEERE" Company Model NO 5310, which is green and yellow in color bearing Reg. no WB 88E 9900, Bearing chassis no-1PY5310ECLA047942, Engine no- PY3029H139988 Which is attached with a trolley and is loaded with sand/silica.

I ASI Sisir Kr Mahato of Radhanagar OP under Bishnupur PS dist Bankura do hereby lodge a suo moto complaint to the effect that today at 03.45 Hrs during course of my night mobile duty which I was entrusted through C/C NO449/21 received a telephonic information that some unknown miscreants are illegally extracting sand and loading them in the trolley of tractor bearing Reg. no WB 88E 9900 (Green color engine and green yellow Trolley) at Baikunthpur Ghat, at Dwarakeshwar River. Accordingly myself along with force rushed to the spot for verifying the information. At 04.35 HRS we reached at the predestined place and found 04 unknown persons were extracting sand and loading them on the trolley of the above noted tractor. However, on seeing the police party all of them fled from the spot, we tried chasing them but in vane. I along with other police personnel and villagers saw the signs of recent and fresh sand excavation from the river bed. I also found the above noted tractor with trolley loaded with sand and accordingly seized the tractor bearing no WB 88E 9900 with trolley loaded with sand under proper seizure list duly signed by witnesses. The seizure of the said tractor with its trolley loaded with sand took place in between 04.55 HRS and 05.35 HRS Thereafter I took custody of the above noted tractor with its trolley loaded with sand and send it to Radhanagar OP under proper police escort.

After I seized the tractor I made enquiry that the registered owner of the above noted tractor bearing no WB 88E 9900 is Sibdas Dey S/O Magaram Dey of village Gumut PO Muninagar PS Bishnupur Dist Bankura and further came to know that this illegal excavation and transportation of sand from the river bed of Darakeshwar River is conducted by one Rakhohari Pal S/O Asit Pal of village Gumut PS Bishnupur Dist Bankura.

Since sand is a national property and illegal extraction of sand is against the law I pray that a specific case may kindly be started Under proper section of Law against the registered owner of tractor no WB 88E 9900 i.e. Sibdas Dey S/O Magaram Dey of village Gumut PO Muninagar PS Bishnupur Dist Bankura, Driver of tractor No- WB 88E 9900, Rakhohari Pal S/O Asit Pal of village Gumut PS Bishnupur Dist Bankura and others.
