Sub - Prayer for lodging IIR

Sir,

With due most respect I ASI Subal Bauri of Bishnupur PS do here by lodged a written complaint as suomoto to the effect that on 15.06.21 at 18.45 hrs, I along with C/222 Sital Banerjee, C/157 Nirmal Ghosh, C/457 Dilip Kr Das and HG Biman Mahat had been detailed for Highway night patrolling duty as scheduled, vide Bishnupur PS CC no- 1827/21 Date- 15.06.21 (This refers to Bishnupur PS GDE no- 715 Date- 16.06.21). In course of my patrolling, on 16.06.21 at about 00.05 hrs I started visit of RG party at vill- Peardoba under Bankadaha GP, PS Bishnupur and found that the local villagers of Peardoba are chasing a group of unknown miscreants who allegedly came to the said village by availing a TATA ace vehicle bearing Regn no- WB 33D/ 1750. Accordingly I along with my team accompanied with the RG parties on chase 02 (two) injured accused persons arrested from different corners of the village, who concealed themselves in different hideouts. In the darkness of night the local villagers manhandled them; however police party managed to rescue them and keep them in mobile van. The local villagers ransacked the aforesaid TATA ace van and capsized the same in which the miscreants allegedly availed it from outside of our PS jurisdiction. On further intervention by searching entire village with the help of local RG parties and arrested 03 (three) injured co-member of miscreants from different hideouts of the said village who also be man handled. During this course 04- Crude bombs, 03-Iron rod, 01 Axe & 01 Medium size Bhojali were also be recovered from their possessions as shown and identified by the RG parties. The injured arrested accused are 1) Saifuddin Choudhury (28 yrs) S/O Musa Choudhury of Vill- Mathuri, PS Garbeta, 2. Kamarul Hossain Mondal (32 yrs) S/O Shamsur Alam of Vill- Nalbona, PS- Garbeta 3. Pear Ali Pathan (27 yrs) S/O Rafique Pathan of vill - Metedahar, Garbeta, 4 Sabir Ali Khan (35yrs) S/O Lt. Noushad Khan of DO, 5. Nasir Choudhury (25 yrs) S/O Hassan Choudhury of vill- Kharkusma, Garbeta, All of Dist- Paschim Midnapur. Over this incident the mob of local villagers are so aggressive any how we could able to rescued all the 05 injured accused from their grips by further re-imburement from EF Police line, Bishnupur in direct supervision of superior officers. After recovery of alleged vehicle bearing Regn no- WB 33D/ 1750, Blue in colour in which "মডল ব্রাদার্স রোড ওয়েজ" written on the Body in white colour, with the help of crane from the PO the following instruments/weapons were also be find out from inside of the driver's cabin: 1) 01- Big hammer with wooden but, 2) 01 Hack-saw blade (Iron cutter) fitted with handle, 3) 01 Cutter plus 4) 02 Big size screw drivers 5) 01 piece of Rope about 4 mts in length, and 6) 02 bottles of country spirits which have been also be seized under proper seizure list duly signed/ thumb impressions by the witnesses and the accused persons. On interrogation, they confessing that they along with (04) others were came with preparation of committing dacoity in Bishnupur PS area. Anyhow rest 04(four) persons succeeded to flee away from the spot viz- 1) Ali Hossion Khan @ Bhatu S/O Lt Mebud Khan of Vill- Metedahar, PS- Garbeta 2) Kalimuddin Sk @ Sejo S/O Sabed Ali Sk of Vill- Kharkusma, Garbeta 3) Amir Choudhury S/O Musa Choudhury of Vill- Kharkusma PS- Garbeta 4) Barik Mallick S/O Not known of Vill- Sukulore, PS- Garbeta, All of Paschim Medinipur. The entire fact in issue was occurred in between 01.30 hrs to 03.00 hrs. All the arrest accused persons not willing to submit complaint against any person over the issue of manhandling.

All the arrested injured persons namely 1) Saibuddin Choudhury (28 yrs) S/O Musa Choudhury of Vill- Mathuri, PS Garbeta. 2. Kamarul Hossain Mandal (32 yrs) S/O Shamsur Alam of Vill- Nalbona, PS- Garbeta 3. Pear Ali Pathan (27 yrs) S/O Rafique Pathan of vill - Meledahar, Garbeta. 4 Sabir Ali Khan (35yrs) S/O Lt. Noushad Khan of DO. 5. Nasir Choudhury (25 yrs) S/O Hassan Choudhury of vill- Khatkusma, Garbeta. All of Dist- Paschim Midnapur send to Bishnupur District Hospital for treatment where they have been admitted due to seriousness of their injuries.

Under this above- fact and circumstances a cognizable case may kindly be registered under proper sections of law for its regular investigation
