In Producing herewith the following seized articles (as per seizure list) and one arrested accused namely Samir Gorai (38 y) S/O- Lt Ajit Gorai, Vill- Ajodhya PS-Bishnupur Dist-Bankura

I SI Subham Roy Chowdhury in charge of Radhanagar OP do hereby submit a suo moto complain to the effect that on 19.06.2021 at about 18:05 hrs received a telephonic information that one Samir Gorai (38yrs) selling liquor at Ajodhya morh in his tea shop in lieu of money, this refers to Radhanagar OP GDE NO 427 dated 19.06.2021. After receiving this information I along with force rushed to the spot for working the information out. At around 18:35HRS myself along with force arrived at tea shop of the accused person namely samir gorai, on seeing police vehicle some people who were gathered near to his house escaped from the area but somehow we managed to apprehend the above named person. After searching his house we found that the accused person has stalked a substantial quantity of country spirit namely "CAPTAIN" at his house On being asked he failed to produce any valid document in respect of selling liquor in exchange of money. As such, I seized 33 Bottles of country spirit labeled as "CAPTAIN" each of which is 600 ml aprox market value of which is aprox 33 X 100/Bottle i.e 3300 in quantity from the possession of Samir Gorai (38yrs) S/O- Lt Ajit Gorai, Vill- Ajodhya PS-Bishnupur Dist-Bankura in his tea shop at Ajodhya more the seizure took place from 18.45HRS to 19.05 HRS After preparing proper seizure list duly signed by witnesses and labeled the same and at 19.15 HRS I arrested Samir Gorai (38yrs) S/O- Lt Ajit Gorai, Vill- Ajodhya PS-Bishnupur Dist-Bankura after maintaining all formalities of arrest as per NHRC and the Apex court .

Hence I pray before your kind honors that a specific case under proper section of law may kindly be started against the above noted accused person
