Sub: Prayer for Lodging a FIR

Sir,

I SI Subham Roy Chowdhury in charge of Radhanagar police out Post PS- Bishnupur, Dist- Bankura producing herewith the following seized articles along with original seizure list and beg to submit written complaint against one Sobur Mondal S/O Lt Jalim Mondal of village Belara PS Bishnupur Dist Bankura who is also a FIR named accused person of the above noted case to the effect that on today i.e. on 31.05.21 during interrogation of 02[two] PC accused persons in C/W the above noted case reference , accused persons, namely Ali Mondal S/O Jalim Mondal and Badrul Alam Mondal S/O Abdar Mondal, both of village Belara PS Bishnupur Dist Bankura gave a leading statement that one Sobur Mondal S/O Lt Jalim Mondal of village Belara PS Bishnupur Dist Bankura, a co- accused had stalked huge amount of explosives mixtures and bomb making equipments in his house which was supposed to be used during the commission of the offence on 30.05.21. Accordingly on the basis of that myself along with force and the above noted PC accused persons left PS for holding search & raid at village Belara (This refers to Bishnupur PS GDE no- 1349 Dated- 31.05.21) and search out the house of alleged Sobur Mondal S/O Lt Jalim Mondal at around 10.05 hrs as shown by the PC accused persons. The house situated at Belara village, east facing mud built, straw shaded, thatched hut consisting of single room. During search we found that the male members of the house were not present and only house wife namely Moni Bibi was present. We searched beneath the bed of the living room of Sabur Mondal and found the following articles viz- (i) A polythene bag containing a mixture of explosives making raw materials which seems to be Aluminum Dust, Sulphur, Potash etc, with a pungent smell and has a dark grayish appearance weighing about 3.5 kgs. (ii) Five (05) numbers of sticks densely tied with jute thread & iii) Five (05) Aluminum measuring bowls. I asked Moni bibi that whether she has any valid documents for keeping such explosive related substances but she replied that these substances were collected and stalked by her husband Sobur Mondal for any unknown purpose. The entire items have been properly seized in presence of local villagers, Police party and the wife of Sobur Mondal. House wife Moni Bibi apparently refused to put her signature on the seizure list. The seized raw materials were weighed by using the Govt. supplied weighing kit and 500 gms was taken out as sample and properly labeled by me on the spot.

Thereafter, we held raid within the village for Sobur Mondal but to no good as he is intentionally absconding in order to evade police arrest, he took active part in the crime of dated- 30.05.21 at Belara village [This refers to Bishnupur PS case no 67/21 Dt. 30.05.21 u/s 147/148/149//427/307/186/353/120B IPC 3/4/5/6 ES Act, Sec. 51/ of the NDMA Act, Sec 3 of The Epidemic Diseases Act 1897 (Act No 3 of 1897) & Sec 15A of the WB Maintenance of Public Order Amendment Act- 2017

Hence, under the above circumstances I prayer before you that a specific case under proper section of law may kindly be started against Sobur Mondal S/O Lt Jalim Mondal of village Belara PS Bishnupur Dist Bankura.
