Sub:- Prayer for lodging specific case u/s 379/411/413/414 IPC and 21 of Mines and Minerals Act-1957 against Saheb Mahadanda (20 yrs) s/o- Piru Mahadanda of vill- Lego Uttarpara, PS- Kotulpur, Dist- Bankura.

Sir,

In producing herewith the arrested person namely Saheb Mahadanda (20 yrs) s/o- Piru Mahadanda of vill- Lego Uttarpara, PS- Kotulpur, Dist- Bankura, along with one seized Tractor bearing Registration No- WB 67B/1721, loaded with sand, I beg to state that on 28.06.21, I ASI Jayanta Das along with force, vide C.C. No- 1422/21, and Kotulpur PS GDE No-1367, Dt-28.06.2021; was performing Special mobile duty at Netaji more. As per specific information myself placed Naka at Sagarmeja under Kotulpur P.S., Dist-Bankura.

During Naka checking myself with my accompanied force gave signal to stop the Tractor bearing Registration No- WB 67B/1721. But the driver of the tractor violating the signal proceeded towards road on high speed. Then we the Police party chased the Tractor and detained near Sagarmeja Bazar. On my asking the driver of the Tractor failed to produce any documents in respect of the said Tractor, neither he produced any challan in respect of the sand loaded with it. During interrogation, the driver admitted that the sand is loaded at Gogra area. He also failed to explain anything in this regard. During interrogation, it could be learnt that the sand was transported from Gogra area, PS-Kotulpur, Dist-Bankura by illegal manners.

Thereafter, I seized the aforesaid Tractor bearing Registration No- WB 67B/1721, loaded with sand, as per proper seizure list, in between 18.45 hrs to 19.05 hrs; and arrested the person at 19.05 hrs, as per procedure laid down in Cr.P.C., and brought the person with seized Tractor in to P.S.

So, I pray before you to lodge a specific case against the person, as per specific section of law.
