Sir,

In producing herewith with the seized articles as per seizure list I beg to submit that on 19.06.21, during my mobile duty, I, PSI Krishna Murmu of Onda PS received a secret information from my source that one Bahadur Bauri [M/26 yrs] S/O-Subhamoy Bauri of Vill+ P.O-Mankhamar, PS Onda, Dist. Bankura is illegally manufacturing and sell Id liquor at Mankhamar village under Onda PS. Accordingly duty officer diarized the information vide Onda PS GDE no 782 dtd. 19.06.21 through duty officer and shared the information to OC, Onda PS. Then I, PSI Krishna Murmu of Onda PS along with C/712 Susanta Chakraborty, C/1460 Anandamoy Mondal, NVF/733 Jayanta Mahata, proceeded to the Mankhamar village to work out the information, the CC No. 1618/21, dt 19.06.21, at about 17.25, hrs we reached at the house of the accused person at Mankhamar village and saw that the said person is manufacturing ID Liquor at his house by placing aluminum handi over the chulli. On being seeing police he flew away from his house. As such I searched the place and found ID liquor containing approx total 20 ltr. in a 02 (two) plastic jerrican (10 Ltr. X 2) and 01 Ltr X 01 and sample ID liquor, of 1 liter in a bottle, 4 plastic glass, 4 pieces of aluminum handi and one funnel used for manufacturing of ID liquor. During local enquiry it could be learn that the above noted person continuing his business without any valid license or valid papers. Accordingly, I seized the said articles under proper seizure list followed by proper sealing & labeling duly signed by the witnesses. As the said Bahadur Bauri has committed an offence which attracts sec. 46 of Bengal Excise Act 1909.

Therefore, I pray that necessary steps may kindly be taken against accused Bahadur Bauri [M/26 yrs] S/O-Subhamoy Bauri of Vill+ P.O-Mankhamar, PS Onda, Dist. Bankura under proper section of law.
