Sir,

In producing herewith the seized articles as per seizure list and I beg to submit that on 27.06.21, during my evening mobile duty I, ASI Adhir Mallik of Punisole OP under Onda PS received a secret credible information from my source that one Purna Murmu [M/65 yrs] S/O-Lt. Biswanath Murmu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura and Chuniram Tudu(M/55 yrs) Lt. Bimal Tudu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura are illegally manufacturing and selling Id liquor at Mitrabandh village under Onda PS. Accordingly I informed it to the IC, Punisole Out Post which he diarized vide Punisole OP GDE No 637 Dated 27.06.2021 and directed me to work out the information. Then, I ASI Adhir Mallik of Punisole Out Post under Onda PS along with C/990 Mijanur Mondal, C/265 Rajesh Senapati, NVF/511 Sunil Kumar Mahata, NVF/0583 Sanat Mahanty proceeded to the Mitrabandh village to work out the information, vide CC No. 518/21, dt 27.06.21, at about 17.35, hrs we reached at the house of the accused person namely Purna Murmu at Mitrabandh village and saw that the said person with another Chuniram Tudu are manufacturing ID Liquor at the house of Purna Murmu and selling it to the customers in exchanged of money. Looking us, they tried to flew away from the place with the customers. Myself along accompanying force succeeded to apprehend them. In presence of them and other witnesses I searched the place and found ID liquor containing approx total 30 ltr. in a 03 (three) plastic jerrican (10 Ltr. X 3) and sample ID liquor of 1 liter in each 02 (two) bottle, 6 plastic glasses, and one funnel used for manufacturing of ID liquor. During local enquiry it could be learnt that, the above noted persons continuing their business without any valid license or valid papers. Accordingly, I seized the said articles under proper seizure list followed by proper sealing & labeling duly signed by the witnesses and arrested the above noted accused persons informing them the ground of arrest maintaining all arrest rules. As the said Purna Murmu [M/65 yrs] S/O-Lt. Biswanath Murmu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura and Chuniram Tudu(M/55 yrs) Lt. Bimal Tudu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura have committed the offence which attracts sec. 46 of Bengal Excise Act 1909.

Therefore, I pray that necessary steps may kindly be taken against accused persons namely Purna Murmu [M/65 yrs] S/O-Lt. Biswanath Murmu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura and Chuniram Tudu(M/55 yrs) Lt. Bimal Tudu of Vill:-Mitrabandh P.O-Ratanpur, PS Onda, Dist. Bankura under proper section of law.
