In producing herewith 05 arrested persons namely 1) Uttam Kumar Atha (40Y) S/O- Birendranath Atha of Katjuridanga, PS + Dist- Bankura, 2) Uttam Kumar Samanta (43Y) S/O- Narayan Samanta of Katjuridanga, PS + Dist- Bankura, 3) Tapas Bir (42Y) S/O- Debu Bir of Keshra, Katjuridanga, PS + Dist- Bankura, 4) Bappa @ Baidyanath Deoghoria (39Y) S/O- Gopal Deoghoria of Uttarayan Pally, Katjuridanga, PS + Dist- Bankura & 5) Piyali Das D/O- Lt Harisadhan Das of Rathtola, Burdwan, PS- Burdwan, Dist- Purba Burdwan with the following seized articles- (i) Six pices Condom styled as "KAMASUTRA" in sealed packet, (ii) Cash RS 2500/- (Two thousand five hundred only) seized from the possession of arrested accd person SI no 01 to 04. (iii) 05 (Five) pics condom styled as "PLAY GUARD" in sealed packet from the possession of the arrested accd as noted in SI no 05. (iv) Two pices of used condom from the bed room of Sanjib Gorai @ Tira.

On 03.07.2021 at about 23:35 hrs received a credible information that some prostitution is going on in the house of one Sanjib Gorai @ Tira at Beliatore Shyam Bazer near Station road by the side of Bankura Sonamukhi pitch road P.S.- Beliatore, District- Bankura, immediately getting the information myself left for Beliatore PS and after arriving there, I informed the matter secretly to O/C Beliatore PS and as per my direction this information has been diarized, vide Beliatore PS GDE no- 114 dated- 04.07.2021. Myself with O/C Beliatore PS firstly verified the information through our reliable disinterested persons and came to the opinion that the information was true. Thereafter under my direction a team has been formed comprising both male and female police personal. Before proceed to work out the information, briefed all team members about our purpose and share the information to all. Then making all preparation we left for the place i.e. Beliatore Shyam Bazer, near Station road, this refers to Beliatore PS Spl. CC no 44/21 date- 04.07.2021.


Our source identified the house, it is a double stored east facing PAKA house on SH 08 (Bankura Sonamukhi Road) at Shyam Bazer under PS- Beliatore, Dist- Bankura. It has come to learnt that the name of the owner of that house is one Sanjib Gorai @ Tira S/O- Subhas Gorai of Beliatore Shyam Bazer, PS- Beliatore, Dist- Bankura. As per my direction and previous briefing we firstly cordoned the house carefully and then myself with O/C Beliatore PS knocked the main entrance of the house, but none responded to our call, after prolonged attempt we managed to open the main entrance of the house anyhow. There are three rooms on the ground floor. Out of three rooms two were opened but rest one was closed from inside. We heard some whispering from the inside of the room. We knocked the door and asked the person to open the door but they did not do so. However after several attempts and applying mild force we managed to open the door and found four male and one woman inside the room in quite unfair and compromising like condition. We disclosed our identity to them and then interrogated them thoroughly. On being interrogation they disclosed their identity as mentioned above which is subject to verify. On being asked by me of their presence at there in such odd time and reason for such unfair activities in such a compromising situation, they failed to give any satisfactory reply. Further under my direction police team has searched the room as well as all the persons including the woman by our lady police personnel. During search the above noted seized things were found from the possession of detained persons and also found some used condom inside the room in a conceal position. During further interrogation after recovering the articles as mentioned above in

separately and individually all of them lastly confessed that they came there from Katjuridanga, Bankura Town for their sexual enjoyment and by calling the said woman in lieu of money. They also confessed that they are habitual in such type of activities and used to come in that house on a regular interval. On the other hand, during further interrogation the detained woman disclosed in presence of lady police personal that she is habituated in prostitution and today she came there on being called by the said Sanjib Gorai @ Tira in exchange of money. She also confessed that she used to come there in a regular interval as and when called by the said Sanjib Gorai @ Tira. Today after reaching there she found the above noted four persons as customer and they were engaged in sexual enjoyment inside the room with a condition of getting money in lieu of that. On interrogation it was clearly established that said Sanjib Gorai @ Tira has engaged himself in such illegal prostitution racket by allowing and giving his room as brothel, which is unfair and illegal in such public place. Meanwhile police team has also searched the first floor of the house there are also three rooms on the first floor. But during search none could be found there. During search the house owner i.e. Sanjib Gorai @ Tira was not found in the house as he could had managed to escape himself getting the smell of police.

Accordingly all the above mentioned articles were seized under proper memo of seizure separately in presence of police witnesses as no public witnesses could not be found in spite of our hard attempt due to odd hours. Then I arrested the above mentioned persons including one woman by taking all guide lines and arresting measures by disclosing their caused of arrest and brought them to the PS with all seized articles with label.


