Sir,

In producing here with the arrested person namely Bhajan Mondal (34Y) S/O- Tapan Mondal of Rajbandh, PS- Beliatore, Dist- Bankura along with seized article 1) approx. 14 ltrs of ID liquor in one plastic jariken, 3) One bottle one country sprit taken from SI no- 1.

On 15.07.2021 I PSI Manas Majee of Beliatore PS along with C/478 Nandalal Paramanik, C/ 1389 Deepak Bauri, HG-RPR - 061 Sanjit Kammila left from PS to perform mobile duty at PS area vide GDE no- 553 date- 15.07.2021 and CC no- 1167/21 date- 15.07.2021, as per order of O/C Beliatore PS. During my mobile duty at about 15:45 hrs, I received secret source information from my reliable source that the arrested person was selling I ID liquor illegally in his house at Rajbandh village. Accordingly, I informed O/C, Beliatore P.S. and as per direction, myself along with force, left for the house of the accd person at Rajbandh village under PS- Beliatore, Dist- Bankura to work out the information.

On 15.07.2021 at about 16:15 hrs I accompanied by force reached in the house of Bhajan Mondal (34Y) S/O- Tapan Mondal of Rajbandh, PS- Beliatore, Dist- Bankura and we searched his house and found that the accd person stocked approx. 14 ltrs of ID liquor in a plastic Jariken. On interrogation it came to learn that the person stocked the ID liquor with a view to sell and it continued since long time, I asked him to produce license or valid documents, but he failed to do. Accordingly I arrest this person after maintaining all legal formalities of arrest and seized the plastic Jariken containing approx. 14 ltrs of ID liquor, I arranged one glass bottle of 375 ml collected 375 ml ID liquor from the seized Jariken under proper seizure list and label, duly signed by the witnesses and the arrested person, On several request no one came forward to sign in the seizure list.

Under the above circumstance, I request you to start a specific case against the said Bhajan Mondal (34Y) S/O- Tapan Mondal of Rajbandh, PS- Beliatore, Dist- Bankura and arrange for its investigation.
