Sub: Prayer for lodging FIR against Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura.

Sir,

In producing herewith the seized article (1) 22 bottle of country sprit labelled as "CAPTAIN", measure 600 ml each, (2) one bottle of CAPTAIN country sprit, measure 600 ml collected as sample from the each bottle SI No 1 & 2 and duly sealed and labeled by me, I ASI Nirmal Kr. Satpathi of Bishnupur PS do here by lodge complaint against Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura to the effect that on 17.07.21 at about 17:05 hrs received secret information over telephone from duty officer of PS that illegal sale of ID liquor is going on at Tin shaded gumti of Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura near 'Mandal Cold Storage' (This ref. to Bishnupur P.S. G.D.E. no- 844, Dt- 17.07.21) Accordingly as per order of I/C, Bishnupur P.S. I accompanied by force namely C/189 Ananda Mohan Khan, C/1477 Rajen Adhikary left for 'Mandal Cold Storage' to work out the information.

On 17.07.21 at about 17:25 hrs I accompanied by force reached Tin shaded gumti of Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura near 'Mandal Cold Storage'. While proceeding to his gumti as identified by the local people, Seeing Police some persons who were sitting in the court yard of his gumti and taking liquor started to flee away. We chased behind them. But all of them including manufacturer Ramen Das managed to escape from there. I called some disinterested persons. In presence of some villagers and police personnel in between 17:25 hrs to 17:45 hrs searched the gumti from where those persons fled away and found (1) 22 bottle of country sprit labelled as "CAPTAIN", measure 600 ml each, (2) one bottle of CAPTAIN country sprit, measure 600 ml collected as sample from the each bottle SI No 1 & 2. On local enquiry I came to learn that the owner of that gumti is Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura who was managed to escape from there. He has been selling liquor illegally from gumti and he is running this illegal business since long. I arrange to collect one bottle of CS as sample and sealed, labeled, and seized the same in presence of police witnesses namely C/189 Ananda Mohan Khan, C/1477 Rajen Adhikary both of Bishnupur PS under proper seizure list duly signed by them. On several request no villagers came forward to sign in the seizure list. The seizure of the above articles was made in between 17:25 hrs to 17:45 hrs duly Signed by the Police person.

On the spot on being search and ask neither he nor any one in favour of him came forward and produce any valid license against his illegal sale of ID liquor. I interrogated him and during interrogation he confessed his guilt. Accordingly at 17:55 hrs I arrested the accused person namely Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura. The approximate value of the article seized and destroyed is Rs 2200/- only.

Under the above circumstance, I request you to start a specific case against the said Ramen Das @ Bura (30 yrs), S/o- Swapan Das of Vill- Netajinagar Colony, PS- Bishnupur, Dist- Bankura and arrange for its investigation.
