Sub: Request for demolition of Illegal construction happened in LR Plot No. 252, Mouza: Kalla, JL No. 180 Nature of Land: Baide, within Block + P.S: Onda, District: Bankura, Pin Code: 722 144 at the instance of one Sri Haradhan Mondal son of Sri Naba Kumar Mondal residing permanently at Village + P.O: Hatashuria, P.S: Barjora, District: Bankura, Pin Code: 722 204;

This is to inform you that, I am a resident of Kolkata and also I have several landed properties within Block + P.S: Onda, District: Bankura, Pin Code: 722 144.

Also I am one of the co owner of the property in respect of LR Plot No. 252, Mouza: Kalla, JL No. 180, Nature of Land: Baide, within Block + P.S: Onda, District: Bankura, Pin Code: 722 144. The said plot is used for cultivation and still now the same is going on.

When I visited the said Plot on 15.05.2021, I found that one person has constructed brick build structure over the said LR Plot No. 252, Mouza: Kalla, JL No. 180, Nature of Land: Baide, within Block + P.S: Onda, District: Bankura, Pin Code: 722 144 by changing its' nature and character. Also the said construction has not been sanctioned by the local Panchayat in any manner.

On local enquiry I came to know that, one Mr. Haradhan Mondal as stated above has constructed the said structure and the same is being used commercially after purchasing the undivided portion of land from other co- sharer by changing the nature and character of the Land.

The said construction has been made without sanction and the quality of construction is poor, the materials used are also of inferior quality. The said construction may be collapsed at any point of time. Thus the said construction is hazardous for human life and safety and also the drainage system may be damaged at any point of time.

In this premise, I am requesting you to demolish the said construction over LR Plot No. 252, Mouza: Kalla, JL No. 180, Nature of Land: Baide, within Block + P.S: Onda, District: Bankura, Pin Code: 722 144 made by Sri Haradhan Mondal to save the eminent danger.

Please act in according to the law.
